Sir,

In producing herewith following seized articles as per seizure list viz (i) one goods carrier (Truck) having Registration No WB 78 9467 loaded with illegally mined river bed materials.

I, ASI Prabal Sarkar of Pradhannagar Police Station, Siliguri Police Commissionerate, do hereby submit this written complaint for your kind consideration and necessary legal action.

On 04.09.2025 at around 12:10 hrs, I received specific source information regarding illegal mining and transportation of river bed materials from Mahananda river bed, Lalchand Ghat Milan More, falling under the jurisdiction of Pradhannagar Police Station, District Darjeeling. The information stated that such materials were being illegally extracted and transported without any valid permit.

Accordingly, I diarized the information at the Police Station vide Pradhannagar PS GDE No. 211 dated 04.09.2025 and informed you about the matter. As per your kind direction, I proceeded to the location along with SI Bandhan Roy, ASI Biplab Kumar Das, and force in a government vehicle for verification.

While on my route, I received a further tip-off that the suspect vehicle had already left the site and was heading towards Devidanga. We then strategically parked our vehicle by the roadside near Devidanga and kept watch. At around 12:20 hrs, we observed a truck bearing Registration No. WB 78 9467 approaching. However, upon spotting us, the driver accelerated and attempted to flee towards Adha Ghat, Devidanga. After a chase, we managed to intercept and stop the vehicle. However, the driver escaped on foot, abandoning the truck at the scene.

Upon inspection, the truck was found to be fully loaded with illegally mined river bed materials. Preliminary enquiry revealed that both the driver and owner of the vehicle have been involved in the illegal transportation and sale of such materials for wrongful gain over a considerable period of time. Despite attempts, I could not trace the driver and owner at the spot.

Accordingly, I seized the vehicle along with the illegally mined materials as per proper seizure list and under the norms of the Bharatiya Nagarik Suraksha Sanhita (BNSS). The seizure process was duly videographed by Sri Somnath Bose, S/O Sushil Chatterjee, a resident of Arabinda Pally, Gokhel Road, Ward No. 22, PS Siliguri, Dist. Darjeeling, between 12:30 hrs to 12:40 hrs.

The seized vehicle, along with the materials, has been brought to Pradhannagar Police Station for further necessary action.

In view of the above, I request you to kindly register a specific case under appropriate sections of law against the driver and owner of the truck bearing Registration No. WB 78 9467 and initiate a thorough investigation into the matter.
