plaining regarding the unauthorized use of my
debit card and fraudulent withdrawal of
money from my bank account. My account
details are as follows: Account no-1642412644, Bank
Branch - Central Bank of India, Shirmandi's
Branch. On 01/09/2025, while updating my pass-
book, I was shocked to find that amount of
₹ 7,000/- (18/08/2025, 19/08/2025, 20/08/2025, 21/08/2025,
01/09/2025) had been withdrawn from my acco-
unt with my knowledge or authorization from
SBI IAF Camp ATM as per my passbook. As soon
as I found out, I looked for the ATM card
but couldn't find it. We suspect our house
help Falguni Singha, husband name - Dhruvho
Singha, Mobile no-8972427282 to be involve
in this crime as since shared the informati-
on, she has switched off her mobile and
stopped responding to our calls. This incident
amounts to theft, cheating and unauthorized
use of banking instruments, and caused
me significant financial loss and mental

distress. I am enclosing here with copies of my bank passbook entries showing the disputed withdrawal, debit card details, and identity proof for your reference.

I request your urgent intervention and assistance in this matter
