I Sashi Kala Rai aged 35 years daughter of Tul Bahadur Rai
Itahari, Sunsari, Nepal (Swagat Marg). Today I was flying from
Air India Express flight no ~~IX2756~~ IX2756 Bangalore to Bagdogra
Seat no 3E, PNR L8ZBMD. During my flight, at first I
asked him to change my seat and changed the seat 3D.
Earlier I was in 3E. During the journey the fellow passenger
with whom I have changed the seat has multiple time
touched me in wrong manner. I was avoiding physically. However,
he was keep on touching me intentionally throughout the
journey. This is the first time, I have experienced
such thing and I was so scared and because of the shame,
I was unable to raise any complaint during the flight.
However, after landing nearby the belt 2, I approached
one of the staff of the airlines and informed him about the
whole incident. Then after, with the help of Air India Express staff,
the matter was raised with the airport security staff. Subsequently
they stopped the fellow passenger. Later, I came to know
his name is MD Khalid (C/o Madiurrahman, S/o of AZAD NAGAR
ward 15 block Araria Bihar, who have misbehaved me within journey.
This is my complaint that inappropriate action from your end
may be taken against MD Khalid.
