The incident came to my knowledge today on 4th September 2025 at approx 1:00pm

The details of the incident are as follows:

1. On 2nd August, 2025 I had winded up (to bring to a conclusion) the factory, resigned all my employees or quit their jobs. Having behind all the plant machinery and tools as it is unblemished, at the same position under the constructed shed.
2. Upon returning today, I noticed that theft has been occurred things was missing from its usual place, I immediately checked the surroundings of my factory, and found signs of forced entry and disturbance inside the factory.
3. The missing things is described as (1). All Electric wiring (2). Small Hand Tools: - Grinder Machine, Cutter Machine, Blower Machine (3). Stabiliser Components (4) Brass items from Electric Panel Board.

I kindly request that a thorough investigation be carried out into this matter and the necessary action be taken to recover the stolen machinery and apprehend the culprit(s),

I am hopeful that the police will act swiftly in this matter and ensure justice is served.
