Respected Sir,

I, SI. Gopal Mandal presently posted under your kind disposal lodging this written complainant against The Secretary & President and members of an organization named and styled as Noor-E-Mujjassam, Hill Cart Road, Venus More, Siliguri to the effect that on 04.09.2025 was 1500th Birth Anniversary of Prophet Muhammad over this occasion Noor-E-Mujjassam approached before the competent authorities to hold a "Religious programme on the eve of the 1500th Birth Anniversary of Prophet Muhammad" at Venus More I.e: Safdar Hasmi Chowk, Siliguri also they demanded to setup a temporary stage in the middle of the road, considering the nature their demand the competent authorities refused to grant any permission for setup any such stage and the program. In this regard the Noor-E-Mujjassam committee was communicated vide a memo with a direction that they should not erect a stage in a manner that obstructs the road and causes obstruction to the free flow of traffic and public in general at Venus More i.e: Safdar Hasmi Chowk, Siliguri. Keep in mind about the matter myself along with other officers and force under the direction of superiors was deputed at Venus More i.e: Safdar Hasmi Chowk, Siliguri to avoid any law and order situation. At around 19.00 hrs myself along with force went to Venus More i.e: Safdar Hasmi Chowk, Siliguri and took up duty and found the said the Noor-E-Mujjassam committee erect a stage by partially blocking the PWD road which headed towards Sevok more. At the same time many religious believers gathered near the stage holding religious flags. Seeing the crowd myself with the help of other officer and force and Police personnel of Traffic unit started controlling the traffic. After that we searched for the organizers and found that the president, secretary and members of Noor-E-Mujjassam committee had organized the program and they found unavailable from the area. The crowd of people attending the event and the closure of government roads to set up the stage caused traffic congestion. After discussing with my superiors, we decided that at this time instead of stopping the program and hurting people's religious beliefs we should manage traffic properly. Thereafter By 10:30 PM, we were able to stop the religious ceremony so as not to offend anyone's religious beliefs, and with the help of local people, the stage on the road was removed.

Over this facts and circumstances I pray before that a specific case may kindly be initiated against The Secretary & President and members of an organization named and styled as Noor-E-Mujjassam, Hill Cart Road, Venus More, Siliguri for illegally and unlawfully assembled in the middle of the road under the jurisdiction of Siliguri PS, blocking the free flow of traffic, obstruct and restraining and disobeying the direction of public servant and arrange for it's investigation.
