Subject : FIR against my husband Sanjib Karmakar.

Respected Sir/Madam,

I Smt. Lata Dey Karmakar, wife of Shri Sanjib Karmakar, Daughter of Babul Dey aged about 38 years presently residing at my parental home at Aurobindo pally, Ward No. 20, Siliguri, beg to lodge the following complaint against my husband Sanjib Karmakar for your necessary action.

That I am legally married to Sanjib Karmakar on 13.05.2001 and out of wed-lock we have a son named Syan Karmakar aged about 20 years. due to ongoing disputes, persistent cruelty, physical violence, and harassment by my husband, I have been living separately from him for the past 5-6 months at my parents home at above mentioned address with my son. On Yesterday i.e. 01.09.2025 at around 01.30 p.m. my husband called me to come his residence and to collect my dresses and belongings from his house, and on today I went to my matrimonial home at J.C. Bose Road, Hakimpura, Ward No. 17, Dist. Darjeeling, Siliguri at 12.30 p.m. along with my son in good faith to collect all the belongings, and when I reached my matrimonial home I saw that my all the belongings are lying in the drain and when I asked my husband that why you thrown my all belongings in the drain then he suddenly assaulted me, beat me mercilessly, abused me in filthy language, insulted me in public view, assaulted my son and also beat my son and tried to strangled his neck to kill him, and gave explicit threats to kill me and my son, thereby causing severe physical injuries in my stomach, hands and chest and since the incident my son is suffering from breathing problem and mental trauma.

Therefore, I pray that an FIR be registered against Sanjib Karmakar. Immediate legal action including his arrest be taken, my safety and that of my son be ensured, and necessary police protection be arranged forthwith. I am also enclosing the medical documents.
