With due respect, I am producing herewith two accused person namely 1) Gakul Nepal (39) s/o Jadunath Nepal of Town no 1. Chitalmari PS Dhekiajuli Tezpur Dist Sonitpur Assam 2) Bimal Thapa (30) s/o Ganesh Thapa of mindipathar Dist Goalpara PS Krishnai Assam under arrest along with seized cattle and seized vehicle;

- 1 Six (06) numbers of Buffalo and six (06) no of Buffalo calves in black color and different size.
- 3. One Vehicle (Truck) having Registration No. AS 18 AC 9147 which was loaded with Buffalo and Buffalo calves.
- 3. One Driving License having No. ML 13 20210003124 in the name of Gokul Nepal (39) s/o Jadunath Nepal of Town no 1. Chitalmari PS Dhekiajuli Tezpur Dist Sonitpur Assam, valid upto 16.12.2031.
- 1, LASI Anamika Ghosh Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint against the above noted accused persons to the effect that on 05.09.25 night received a secret source information that one vehicle are being loaded buffalo illegally coming Jalpaiguri side from Phansidewa side without documents/papers and if immediate action is taken, it can be apprehend. Accordingly I shared the information to you and duty officer of PS. Thereafter as per your direction myself along with NVF 202 Khokon Sarkar, NVF 129 Md. Mainu left for noukaghat to verify the veracity of information. At around 02:30 hrs hrs we reached at Noukaghat and after some on the basis of secret information we intercepted the one vehicle having No. AS 18 AC 9147 and apprehended the driver and helper of the said vehicle. On checking the vehicle we found Six (06) numbers of Buffalo and Six (06) no of Buffalo calves in black color and different size were loaded on the vehicle. On being asked the apprehended driver and another person disclosed their name and address mentioned above and admitted that one is the driver of the said vehicle and one is the helper of the said vehicle and also stated they were carrying the buffalo in his vehicle from somewhere from Bihar side towards Assam for selling the same illegally for their wrong full gain. On asked, they failed to produce any License/ papers in support of carrying the said buffalo in that vehicle and also failed to produce any papers/documents in respect of the said buffalo. It is crystal clear and reason to believe that the above noted accused driver and helper procured the said buffalo by illegal means or by stolen means for dishonestly dispose the same to earn huge money illegally. On further checking it was found that there was no arrangement made for food and water for the said Cattles as per Govt. rules. Besides this there was no sufficient space for the Cattles in that vehicle. The apprehended accused driver and helper of vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized Six (06) numbers of Buffalo and Six (06) no of

Buffalo calves in black color and different size 3. One Vehicle (Truck) having Registration No. AS 18 AC 9147 which used to carry the seized Buffalos 3. One Driving License having No. ML 13 20210003124 in the name of Gokul Nepal (39) s/o Jadunath Nepal of Town no 1. Chitalmari PS Dhekiajuli Tezpur Dist Sonitpur Assam, valid upto 16.12.2031 and the vehicle having registration no AS 18 AC 9147 from the possession of Gakul Nepaland Bimal Thapa as per proper seizure list duly sign by the witnesses and arrested the apprehended person u/s 35 BNSS after informing the ground of arrest and issuing proper memo of arrest. The seizure and arrest have been made in between 03-05 hrs to 03-55 hrs. The seized cattle's are kept at Amaidhighi Khoar, Fulbari as safe custody.

Under the above circumstances, I pray to you that a specific case may kindly be started against the above noted arrested persons namely Gakul Nepal (39) s/o Jadunath Nepal of Town no 1. Chitalmari PS Dhekiajuli Tezpur Dist Sonitpur Assam 2) Bimal Thapa (30) s/o Ganesh Thapa of mindipathar Dist Goalpara PS Krishnai Assam of the above noted seized vehicle having No. AS 18 AC 9147 to arrange for its investigation.
