Subject: FIR against biker for road accident, damage to vehicle, misbehaviour, physical assault and life threatening.

Respected Sir,

I, Rimo Chakraborty, resident of Jalgaon, Dist Alipurduar, hereby lodge a complaint against a biker for causing damage to my vehicle and physically assaulting me.

On 6th sept 2025 at 1:26pm, I was travelling in my vehicle bearing registration number WB 73N 9669 from Jalpaiguri towards Siliguri. While on Burdwan Road Opp Imperial Hotel, P&T More, (near SP Road), Siliguri, my vehicle was stopped near a traffic point. At that moment, a biker riding a motorcycle bearing registration number WB 74BC 1932 came from the side and hit my car, thereby damaging it.

When I started recording a video of the damage caused to my car, the biker suddenly became aggressive and physically assaulted me. He also misbehaved with me, used threatening language, and said, "Whatever you can do, do. I will see you later on." and gave me life threatening if I report to police against him. He also clicked my photo and video of my car. Due to the physical assault, I sustained injuries in hand and chest and had to visit Siliguri District Hospital for medical treatment.

I have clear video proof and evidence of the incident, which I am ready to provide to the police during the investigation.

Therefore, I kindly request you to register this complaint as an F.I.R. and take strict legal action against the accused biker for:

1. Causing damage to my vehicle,
2. Misbehaving and threatening me,
3. Physically assaulting me, and
4. Endangering public safety on the road.


I trust you will take appropriate steps against the offender.
