I Shilpi Sen, the above noted Complainant beg to inform you that on dt. 06-07-2025 at about 09:30 pm at night, when I was alone at my rented house at Tyotinagar colony (C/o Nandhu Ghosh) at that time my above named co-tenant, namely Md. Sarfaraj @ Sonu entered into my room and gave me the illicit propolis and when I denied he caught me within his arms and started to fell me on bed, but when I protested he picked up pillow and covered my face forcefully and tried to kill me, but anyhow I managed to release me, then he started beating me brutally with fist & blunt and torn off my blouse and despoiled me, and kicked me on my private parts.

I received severe injury on my person and as a result I managed to escape from there and immediately shifted to Siliguri Distt. Hospital and treated myself there.

Sir the above noted alleged person is of bad character and always have his eye on me, and previously also he has tried to outrage my modesty, but due to fear I couldn't disclose the same to anyone.

Sir, the above noted alleged person is of very desperate & dangerous in nature and he may again take attempt to abuse me sexually. So please take necessary action against him.
