With due respect and humble submission I ASI Abdul Latif of Matigara P.S. beg to Sir submit that today on 04/09/2025 myself along with force were detailed to perform Mobile Patrol duty, vide C.C. No. 2684/25, Dated 04/09/2025 and GDE No. 167, Dated 04/09/2025 from 08:00 hrs to 14:00 hrs. During my said mobile van duty, at about 10:30 hrs, I received a source information that one Tractor loaded with river bed material is coming towards Khaprail More from Himul side under P.S. Matigara having no document/Royalty in respect of said load. Accordingly I informed the matter to I/C Matigara P.S., over phone. After hearing the information he directed me to work out over the information at once. Accordingly I along with force rushed to Lichubagan, Khaprail Road, under Matigara P.S. and found one Tractor bearing No. WB91C0003T.C./1 fitted with Trolley, loaded with riverbed materials running in a high speed towards Khaprail More, Seeing police the driver/owner of said Tractor jumped away from the Tractor. It may be presumed that the Driver/Owner of said Tractor procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from elsewhere and proceeding to deliver the same to their designated customer for their wrongful gain.
