With due respect, I am producing herewith the 05 (five) arrested accused persons namely (i) Rakesh Baraik (27 Years approx), S/o- Sarbawsar Baraik of Gulma Bagan tin line, PS- Pradhannagar, Dist-Darjeeling, (ii) Prasenjit Das @ Kalu (24 Years Apporx), S/o- Santosh Das of Narayan Pally, PO- Kadamtala, PS- Matigara, Dist- Darjeeling, (iii) Md. Sonu (38 Years approx), S/o- Md. Mansur of Kuli Para, Near Bajrangbali Mandir, PO+PS- Pradhannagar, Dist- Darjeeling (iv) Binoy Munda (25 years approx), S/O- Lt. Philip Munda of Gulma Kher line, PS- Pradhannagar, Dist- Darjeeling, and (v) Bishal Lama (19 years approx), S/o- Sekhar Lama of Promod Nagar, Po+ PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

1. ASI Bikash Roy of Matigara PS, Siliguri Police Commissionerate beg to state that on 05.09.2025 at 23:10 hrs, received a secret source information that a gang of miscreants were assembled at a vacant land of SJDA opposite of Chandmuni Juniour Basic School under Matigara PS, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Pati Colony area. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Chandra Prakash Adhikari, C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Chandmuni Juniour Basic School, PS- Matigara, Dist.- Darjeeling to work out the information in hand vide Matigara PS GDE No. 262, Dated- 05.09.2025. At about 23:20 hrs on 05.09.2025 we arrived at near Chandmuni Juniour Basic School under Matigara PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled at a vacant land of SJDA and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 05 (five) persons of them. On interrogation, the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation for committing dacoity in Pati Colony area. They also stated that others 05/07 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted article from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest was made on 05.09.2025 in between 23:25 hrs to 23:52 hrs. The whole process of search & seizure was made under video graph.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Rakesh Baraik (27 Years approx), S/o- Sarbawsar Baraik of Gulma Bagan tin line, PS- Pradhannagar, Dist-Darjeeling, (ii) Prasenjit Das @ Kalu (24 Years Apporx), S/o- Santosh Das of Narayan Pally, PO- Kadamtala, PS- Matigara, Dist- Darjeeling, (iii) Md. Sonu (38 Yeras approx), S/o- Md. Mansur of Kuli Para, Near Bajrangbali Mandir, PO+PS- Pradhannagar, Dist- Darjeeling (iv) Binoy Munda (25 yrs approx), S/O- Lt. Philip Munda of Gulma Kher line, PS- Pradhannagar, Dist- Darjeeling, and (v) Bishal Lama (19 years approx), S/o- Sekhar Lama of Promod Nagar, Po+ PS- Matigara, Dist- Darjeeling and others and arrange for its investigation.
