I, Praveen Paul Lakra s/o Teni Lal Lakra; resident of Maharaji Hata, Srinagar Road, Janta Chowk, Purnea - 854301; am writing to formally report a theft that occurred at my house, located at A-20/11, Uttorayon Township, Matigara, Siliguri - 734010.

When I visited the property on 6th September, I discovered that all bathroom fittings from the first floor had been stolen. Upon inspection, I observed a small section of glass removed from the balcony door, which was carefully kept aside. Although the balcony doors appeared shut, I noticed that the latches were open. Additionally, the contents of the house were overturned and scattered.

Similarly, bathroom fittings were also missing from the ground floor, where signs of tampering were evident - specifically, missing latches and screws were found on the front door. Unfortunately, the ground floor was locked, and we were unable to fully assess any further losses, especially of potential valuables.

I kindly request you to take necessary legal action and investigation be initiated at the earliest, and that necessary actions be taken regarding this matter. Please let me know if any further information or documentation is required from my side.
