Respected Sir,

I, Vishal Agarwal, son of Binod Kumar Agarwal, proprietor of Shree Amar Suhagan, situated at Mangal Pandey Road, ward no. 09, Khalpara, PS-Siliguri, Dist. Darjeeling wish to lodge a formal complaint regarding a theft at my shop.

On 07/09/2025 at around 10:45 AM, when I arrived to open the shop, I was shocked to find the premises ransacked. Several valuable items had been stolen, including:

- Cash amounting to approximately Rs. 30,000-/-
- 25 silver coins weighing about 100 grams each
- Expensive sarees, lehengas, and garments worth around Rs. 5,00,000 - RS. 6,00,000-/(approx.)

Based on my observations, I strongly suspect the involvement of my former staff named, Sameer (Mobile: 8101292049), as well as a furniture worker who had been working at my shop for the past one and a half months.

I kindly request you to register this complaint as an F.I.R., thoroughly investigate the matter, and take appropriate legal action against the culprits at the earliest.

I shall be available to provide any further details or assistance required during the investigation.
