Sir,

I, Shubhankar Sen, Son of Shib Sankar Sen, resident of Group D Campus, NBMC, P.O. Sushrutanagar, P.S. Matigara, Dist- Darjeeling, would like to inform you that ^{Yesterday} ~~today~~ at about 12:00 pm at noon when I called my friend namely Gayatri Kundu, wife of Lt. Surajit Kundu resident of 2nd lane, Alphonsa road near Arati Apartments, P.O. Sushrutanagar, P.S. Matigara, Dist- Darjeeling regarding some work issues, after talking with her I disconnected the call, then suddenly after 2-3 minutes, her son namely Mohit Kundu, from his mothers phone called me and started threatening me with dire consequences without any provocation and when I confronted him, he told me come in front of his house and after 15 minutes when I went outside his house he came out of his house with a Sharp Weapon (Ramdao) and threwed the Ramdao towards me and started punching me in my face and as a result I fell down and then started kicking me in my chest and then also bit my hand and when I shouted for help and the said miscreant seeing passerby coming to rescue fled away.

Following the incident, I was immediately taken to North Bengal Medical College and Hospital for medical treatment.
