Respected Sir,

With due regards, I, SMT. SHYNI GHOSH, Daughter of Sri Rama Pada Ghosh, Resident of Netaji Pally, Ward No. 22, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734006, would like to lodge this written complaint before your good authority to the effect that I got acquainted with one SRI BISWAJIT GHOSH in the year 2015 and after 5 years of relationship, finally, we got married and our marriage was solemnized on 17/01/2020 in accordance with Hindu Rites and Customs, after observing all formalities of a valid Hindu Marriage on and from my parental house at Netaji Pally, Ward No. 22, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734006.

Sir soon after the solemnization of our marriage I went to my matrimonial house situated at Sukumar Roy Road, Subhashpally, near Lokenath Mandir, P.O.& P.S.- Siliguri and started to reside there with my husband and my in-laws. At the time of marriage, my father gave various valuable articles and golden jewelries to the family of my husband as per their demand and wishes and all the golden jewelries and other valuable articles are still in the custody of my mother-in-law. Sir, few days after our marriage, I started to notice that the behavior of my husband and my in-laws towards me drastically changed and my husband and my in-law members started to show their dissatisfaction with the items given at the time of marriage by my father and my relatives and they further demanded a sum of Rs 3,00,000/- only and pressurized me to bring the said amount from my parental house and on being refusal, they have started to cause mental and physical torture upon me.

Sir, I being the legally wedded wife of my husband, had only demanded the basic dignity and respect but however, since the very inception of my marriage, I have been subjected to continuous physical and mental torture by my husband and his family members which was further supported by his family members. Furthermore, my in-laws, along with certain other relatives of my husband, regularly used abusive, offensive, and derogatory language towards me and treated me with utmost disrespect. It is also pertinent to mention that my mother-in-law repeatedly taunted me by stating that she had never approved my marriage and had never wanted me to marry her son and that since, I was not willing to conceive a child immediately after my marriage, I was subjected to severe mental and physical torture at the hands of my husband and his family members. Sir, my in-laws regularly instigated

and provoked my husband to misbehave with me, and consistently taunted and encouraged him to divorce me with an intention to ruin my life permanently and moreover, the maternal sister of my husband, namely Smt. Rimi Ghosh also threatened me with dire consequences, stating that they would not hesitate to grab me by my neck and throw me out of my matrimonial house. Furthermore, said Smt. Rimi Ghosh also threatened me that if I refuse to agree to a divorce, then she along with my husband and his other family members would end my life permanently. Sir, it is also pertinent to mention that my in-laws not only subjected me to verbal abuse using filthy and derogatory language, but also humiliated me by insulting my parents, referring to them with deeply offensive terms such as "Cheater", "Bhikhari".

Sir, on 15th March, 2022 my elder sister met with a deadly accident and was fully bed-ridden after the said accident. I asked and requested my husband and my parents-in-law to allow me to visit my parental house to take care of my sister and hearing the same, my husband and his family members got angry and started to abuse me with filthy and derogatory languages and also threatened me that if I go to my parental house, they will not let me to come in ever again in my matrimonial home and furthermore, my mother-in-law in conspiracy with one Rimi Ghosh and one Taniya Ghosh also in a deliberate and intentional manner caused mental torture upon me and instigated my husband to assault me and thereafter, my husband started to assault me physically in front of their family members.

Sir, on 04.07.2024, a distressing incident occurred in my matrimonial house, wherein one of my cousin sister-in-law namely Smt. Taniya Ghosh, over phone abused and humiliated me and questioned about my chastity and character and labeled me as "characterless". She also further alleged that I had sent inappropriate messages to her husband and when I made protest against her such false accusations and allegations and demanded them to show the alleged screenshots of the messages if any, but they failed to show me any such messages and on the contrary, when I protested again, I was forcefully driven out of my matrimonial home by my husband and his family members and with no other recourse available, I have compelled to return to my parental home. And since coming back to my parental home, several times I have attempted to contact my husband over the phone requesting him to take me back to my matrimonial home, but he flatly refused on every occasion, rather abused me using filthy and derogatory language and even blatantly stated that I am a prostitute and I work as a prostitute to earn money.

Sir, it is also pertinent to mention that, during my stay at my parental house, I, have received one Legal Notice from one Sri Sudip Banerjee (Advocate) on behalf of my husband and in that notice, my husband has made and leveled several false allegations upon me and Page | 2

thereafter, in reply to his Notice, I have also given a Reply Notice through my engaged Advocate Sri Chinmoy Saha, thereby denying all the false allegations and in my reply notice, I have also stated that I am ready and willing to return back to my matrimonial home, as I am ready and willing to resume my marital life peacefully with my husband and immediately after receiving the said reply notice, my husband over phone state that he had only sent me the said Legal Notice in order to take some defence and in fact, he is not willing to lead further conjugal life with me and hearing the same I became astonished.

Sir, on 02.08.2025, I went to my matrimonial home accompanied by my parents in order to continue my conjugal life with my husband but upon my arrival, my husband and my in-laws abused me and my parents with filthy and abusive languages, and they flatly stated that they will not allow me to enter and stay in their house and when I asked them as to why they have sent notice asking me to return back to their house, they kept mum and threatened me and my family members with dire consequences by saying that they will allow me only if I fulfil their demanded amount of Rs 3,00,000/- . Sir, it is also pertinent to mention that my in-laws, in active collusion with my husband, have been constantly threatening me with dire consequences and coercing me to agree to a mutual divorce. I, being a helpless woman, had never imagined such a situation and have always desired only a happy and peaceful marital life.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband namely Biswajit Ghosh, father-in-law namely Sankar Ghosh and mother-in-law namely Smt. Rekha Ghosh and my sister-in-laws namely Smt. Rimi Ghosh and Smt. Taniya Ghosh as per the provision of law and obliged thereby.
