l, Sri Anil Kumar Sinha, son of Late Madan Mohan Prasad, aged about 67+ yrs, resident of Devi Chowdhurani Sarani, Alakananda Building, Milanpally, Ward No.-26 of SMC, P.O.- Siliguri Bazar, P.S.- Siliguri, District- Darjeeling, intend to lodge this complaint against the below named persons to the effect as under-

- i. Smt Pragva Pragati, wife of Sri Ambar Raj, daughter of Sri Durga Prasad
- ii. Sri Durga Prasad, father of- Smt Pragy'a Pragati
- iii. Smt Savita Sinha, mother of Smt Pragya Pragati,
  All are residents of Behind Amar Cinema Hall, Tower Chowk, Dudhani,
  Dumka, Jharkhand, Pin-814101.
- Smt Payel, sister of Smt Pragya Pragati,
- v. Sri Pravecn Kumar, brother-in-law of Smt Pragya Pragati,
   Both are resident of Dumka, Jharkhand.
- vi. Smt Priya Pushpam, sister of Smt Pragya Pragati,
- vii. Sri Nishit Shaleen, brother-in-law of Smt Pragya Pragati. Both are resident of- Agam Kuan, Patna, Bihar.

The marriage between my son Sri Ambar Raj has been commenced with Smt Pragya Pragati, daughter of Sri Durga Prasad on 07th day of December, 2023, as per hindu rites and customs. After such marriage my son and daughter-in-law Smt Pragya Pragati started to reside at my rented premises along with my wife and unmarried daughter. Few days after the marriage, the behavior of our daughter-in-law towards us gradually changed in the absence of my son. My daughter-in-law started to misbehave with me, my wife and my daughter. My daughter-in-law intensively mistreated us which increased over time. The amount of torture accelerated when we informed such mistreatment to my son. My daughter-in-law started to abuse us with abusive words a statement. My daughter-in-law refrained herself into taking any care of the well being of me and my wife being senior citizens. My daughter-in-law started to apply immense pressure upon me and my son to

purchase a house as she did not want to reside in a rented house. My daughter-inlaw did not accept my unmarried daughter to reside with us and tortured my daughter mentally upon being unmarried. The family members of my daughter-inlaw as mentioned above started to interfere in my household and created immense harassment towards us for purchasing a house and threatened to detangle the matrimonial tie between my son and my daughter-in-law. My daughter-in-law started to apply the same mental torture and abusive words and statements towards her husband (my son) and upon my son raising objection to such torture my daughter-in-law threatened to involve my entire family into false cases. My daughter-in-law tried to oust me, my wife and my daughter of our house on several occasion by abusing and insulting us. In the month of October 2024 during my heart treatment, my daughter-in-law did not leave a moment to torture me and my wife by severe threats result into my health detoriate. On few occasions while my wife and daughter were not present in the house, I had asked my daughter-in-law to provide me with medicines after lunch. To my utter shock I found my daughter-inlaw used to provide me some medicines apart from the prescribed one with the intention to kill me being a heart patient. My daughter-in-law had no respect towards me, my wife and daughter. Me and my wife being senior citizens and sick have been subjected to immense cruelty in the hands of my daughter-in-law.

On 22<sup>nd</sup> December, 2024 the above-named persons namely Sri Durga Prasad, Smt Savita Sinha, Smt Payel Kumar, Sri Praveen Kumar, Smt Priya Pushpam, Sri Nishit Shaleen via vehicle no.- JH 15AC 3147 along with 3-4 unknown persons visited my house in the afternoon and started to abuse me, my wife, my son and my daughter with inappropriate languages. The above-named persons started to threaten my son with dire consequences if he fails to get an own house and reside separately with his wife, my daughter-in-law. My daughter upon raising protest, my daughter-in-law, Smt Savita Sinha, Smt Payel Kumar, Smt Priya Pushpam and Sri Nishit Shaleen forcibly caught hold my daughter inappropriately and locked her in a room. Sri Durga Prasad, Sri Nishit Shaleen and Sri Praveen Kumar caught my collar and pushed me in my chest knowing that I am a heart patient. My daughter-in-law and her father Sri Durga Prasad assaulted my wife by pushing her. My daughter-in-law willfully left our house with her parents and while leaving the house stole a gold necklace which I had made for my unmarried daughter's marriage alongwith some amount of Rs. 12,000/- approx from my wife's almirah which is kept open. My daughter-in-law took away all her stridhan articles including all her gold jewelries in

the aforesaid vehicle bearing no JH 15AC 3147. Me and my family have been subjected to it. subjected to immense physical assault in the hands of my daughter-in-law and the above-parted to above-named family members which had destroyed our pride and dignity being an aged person. aged person. Since marriage, me, my wife and my unmarried daughter received no love, care and love, care and peace from my daughter-in-law. My daughter-in-law wanted to oust me and my wife being aged along with my daughter being unmarried. She had no respect towards her in-laws.

My daughter-in-law was against the fact that my son takes all our responsibility financially. My daughter-in-law never wanted to reside with her in-laws nor she wanted to reside together with my son and her family. My daughter-in-law is presently residing at her parental house and has deserted my son willfully. Me and my family members have been subjected to immense cruelty in the hands of my daughter-in-law and her family members.

On 31/08/2025 in the evening 3 (three) anti-socials visited my house and gave us threats to settle the disputes on mutual consent upon paying an alimony of Rs. 20,00,000=00 for my daughter-in-law else me and my entire family will be subjected to severe consequences. Upon questioning there whereabout, the anti-social persons abused us with filthy languages and statements.

Due to my illness and upon being into trauma from the aforesaid circumstances I could not lodge a complaint immediately.

Upon the above incident being senior citizens, me, my wife along with my son and daughter are in fear and request your good office to initiate legal action against the aforesaid persons and oblige us.
