Sub: - Urgent request to Register FIR & take strict action for
ASSAULT, MOLESTATION & THREAT TO LIFE

Respected Sir,

I, RUNA SHARMA DUTTA, resident of Agnishwar Apt. Near Dr. Hanuman More, Rabindra Nagar, Sikiguri - 734006, am filing this complaint with utmost urgency regarding a grave incident of physical assault, molestation, & threat to my life & safety that occurred on 8th September 2025 at approximately 9:45 PM.

The detailed sequence of events are as follows:-

- ⊗ From around 7:00 PM, one Tyotimoy Roy, S/o Kallol Roy & his friends were consuming alcohol in an inebriated state in & around the residential premises.
- ⊗ The disturbance continued until around 9:00 PM, post which the said individual along with his associates, attempted to enter the premises by banging on the grills.
- ⊗ Despite his father, Kallol Roy being informed, no responsible action was taken to restrain him, which led to a serious altercation between the miscreants & the residents.
- ⊗ At approximately, 9:45 PM, Tyotimoy Roy & his friends physically assaulted me & my husband & my brother, leading to physical molestation, which caused severe pain on the left side of my chest. A doctor's certificate confirming the same is attached herewith for your peruse.

This is not merely a case of disturbance but constitutes serious criminal offences, including physical assault, molestation, criminal intimidation, & breach of peace. The actions of the accused clearly attract NON-BAILABLE offences under relevant IPC.

In view of the above, I earnestly & firmly request to :-

- Register an FIR immediately.
- Take immediate & strict actions against the accused.
- Ensure necessary protection for me & my family.

This is a matter of grave urgency & any delay in action will further endanger my life & the safety of other residents.

The accused fled the scene in a WHITE SWIFT DZIRE with number plate → WB-04-140075.

I therefore request your good office to take a swift & stricter action at the earliest.
