I, **Sri Bimal Chhetri**, Son of Harish Chandra Chhetri, resident of East Salugara, Ward No.42 of S.M.C., Post Office- Salugara, Police Station - Bhaktinagar, District- Jalpaiguri, do hereby lodge a complaint against the above- named persons, to the effect that the above-named persons have been selling contrabands substances since few months in a guise of a tea shop at near Isabella School, pipe line within the jurisdiction of this police station and on 09-09-2025 at about 6:00 pm to 6:15 pm, I along with my friend Debasish Roy went to request the above-named persons to stop to sell the contraband substances in the locality but they became angry and took out sharp iron rod and assaulted me with the said iron rod, fist and blows. They also broke my silver neck chain and mobile handset, Samsung J-7. The above incident has been shoot and captured by my said friend in his mobile hand set, iphone-12 of Apple company.

Due to the aforesaid assault by them, I sustained grievous injuries on back of my neck, left wrist and backside. I was taken to the District Hospital, Siliguri by my said friend for my treatment.

So, therefore, I humbly request to take necessary legal action against the said person and booked them as per the provision of law at an earliest.
