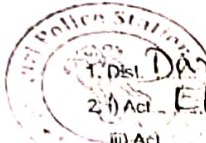

The sites are running without meters to ensure proper illumination in the night for the sake of ensuring safety and security to that particular areas.

It may be noted that WBSEDCL will install new meters at the same places within a few days to set-right the unmetered point as well as to ensure proper metering as per regulatory norms
