I SRI. SUBHAM CHAKRABORTY, son of Sri. Sumanta Nath Chakraborty presently residing at Akshay 03, Swamiji More, Nazrul Sarani, District- Jalpaiguri, most humbly submit this complaint before your esteemed office seeking immediate legal intervention and protection.

- That I am a Lawyer currently practicing in Siliguri Court and due to which at present I
 am residing at Siliguri away from my home.
- 2. That a white Verna, with registration number <u>WB 74 BV 2003</u> and a modified black coloured rear end and black tinted screen, was driven in a rash and negligent manner. The vehicle passed by me approximately at around 3:20 PM today near Astha Medical, Baghajatin Park, brushing against my body. A colleague of mine pulled me to safety at the last moment, preventing serious bodily injury and then and there I shouted at the driver saying that he should drive carefully as the road was heavily crowded at then and the car, with that speed, could hit anyone on the road.
- 3. That after hearing my voice the persons inside the car, stopped the vehicle and charged me head on and started foul mouthing at me with the intent to provoke me to a road affray, but I did not lose my composure and calmly tried to make them understand that their act of rash driving on a crowded road could have caused serious injury to anyone and I could get hit by the car if it was not for my colleague and after hearing me they became more violent and started abusing me with filthy and uncivilized language and all 03 (Three) of them attacked me with fist and blows with intention to grievously hurt me, but I was somehow saved with the help of my colleague.

- 4. That the said persons thereafter followed me to court and continuously threatened me with dire consequences and they also specifically said that they will come after me and my family in future with the intention to commit mischief or hurt grievously.
- 5. That this incident has caused immense trauma to me and I am living in fear.

Under the aforesaid facts and situation, I and my family members are feeling extremely threatened, therefore I request you to kindly treat this as a matter of urgency and take appropriate action to trace and penalize the culprit, I am also willing to co-operate fully with the investigation.
