They began abusing us in filthy language.

Since no male members of my family were present at home, we requested them to leave, but they refused. Instead, they became aggressive.

When my daughter Roshan Khatun tried to stop them, Foul Mohammad caught hold of her hair, threw her to the ground, and assaulted her with fists and blows, Lathi and bamboo. And when Sabera Khatun (pregnant) intervened, she was physically assaulted and kicked on her stomach, causing her condition to become very serious.

They further misbehaved with us by touching our bodies in an indecent and objectionable manner. After then Md. Aftab even attempted to outrage the modesty of my daughter by using force, due to which she sustained severe injuries.

I therefore request you to kindly register this FIR at the earliest, take strict legal action against the accused persons, and ensure the safety of my family.
