[Sub's FIR regarding physical assault and attempt to murder on 4th Sept 2025].

- Respected Sir,

I, Phool Mohammad, son of Late Abdul Hakim, aged 68 years, and Secretary of Madarsa. Mukhtarul Uloom Qarib Nawaz and Mallaguri Mohdamm Committee, wish to lodge the following Complaint.

On 4th September 2025, at around 8:30 PM, I went to the Madarsa to review preparations for the upcoming Eid-e-Milad-un-Naboo procession schedule on 5th Sep 2025. At that time Md. Riyaz son of Late Okhil, was present near the Madarsa along with 15-20 people.

Without any provocation, Riyaz started using ^{abusive} language. ~~When~~ along with Md. Aslam S/O Lt Md. Okhil and his wife Parvina Khatun, Md. Kitab Ali S/O Lt Md. Okhil, Md. Saqib son-in-law of Lt Okhil, Poonam Khatun d/o of Md. Okhil, Renham Khatun d/o of Lt Okhil, Md. Hussain and Md. Zehrun S/O of Md. Muntaq, Md. Chand, Md. Jammal S/O of Md. Inam, Md. Hussain S/O Md. Inam Zitter, Md. Imran S/O Md. Aslam, Md. Shewar S/O Md. Aslam and many others.

Without When I asked him to stop, he along with his companions, began pushing and started assaulting me. Since, I was alone, I immediately called my family members for help. Meanwhile Riyaz and his friend called around 30 local goons and together they launched a violent and brutal attack on me.

They beat me mercilessly with bamboo sticks, iron rods, and also carried sharp weapons such as knives and other objects. Some of them started pelting stones on me. Finally they grabbed me on the nearby railway line with the clear intention of taking my life.

When my son arrived and tried to protect me, they wounded him and assaulted ~~me~~ ~~Saddam~~ and again attempted to kill me. Shortly thereafter my wife and other family members reached the spot, and only then the situation came under some control.

As a 68 years old Senior citizen, I was unable to defend myself against such a large and violent crowd. I am presently seriously injured and ~~bleeding~~ due to this brutal attack, and my life and safety remain in grave danger.

This was a life threatening incident and my family were put in extreme danger due to unlawful and criminal action of Riyaz and his associates.

I therefore request you to kindly register this complaint as an FIR at the earliest, take strict legal action against the accused persons, and ensure the safety of my family and me.
