In producing herewith five (05) accused persons namely (i) Bigen Mahato (24 yrs) S/O Rajendar Mahato of Lohar Patty, Gurung Busty, P.S. Pradhan Nagar, Dist. -Darjeeling (ii) Arun Biswakarma (22) S/O Lt. Raju Biswakarma of Haria Budhabari, PS. Jhapa, Nepal, A/P Darjeeling More, PS. Matigara, Dist. Darjeeling (iii) Biru Roy (28 yrs) S/O Niranjan Roy of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (iv) Santosh Mangar (32 yrs) S/O Lt Mani Kumar Mangar of Dentam, Namchi, PS- Namchi, Dist. South Sikkim, Sikkim and (v) Pinku Das (24 yrs) S/O Late Ananda Das of Lokkhi Colony, Dasarath Bally, Ward No-44, PS- Bhakti Nagar, Dist. Jalpaiguri under arrest along with the following seizure articles viz:- (i) one iron made weapon locally calld as "SHOWRD" measuring 24 inches in length including its 05 inches wooden butt (ii) one iron made weapon locally called as "HASUA" measuring 23 inches in length including its 05 inches wooden butt (iii) one iron made weapon locally called as "SABOL" measuring approx 19 inches in length (iv) one iron made weapon locally called as 'KHURIA' measuring 22 inche in length (v) one iron made hammer measuring 9 inches in length including its wooden handle (vi) one iron made instrument locally called as "PLUS" (vii) one black colour torch light and (viii) one multi colour nylon bag. I, ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted five (05) arrested accused persons and others 06/07 unknown miscreants who involve in this crime, to the effect that on 09.09.25 at 00.25 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled in an abandand railway quarter at BRI Colony under PS-Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at BRI Colony and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 493 dated 09.09.2025 and informed the matter to you. As per your kind order and direction, I along with ASI Biplab Kr Das, ASI Bikash Roy and force all of Pradhan Nagar PS, SPC left for BRI Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night van officer ASI Sanjit Mandal to come to BRI Colony to accompany with us. At around 00. 40 hrs we arrived at BRI Colony under PS Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer ASI Sanjit Mandal arrived there and accompanied with us. I shared the information with them and briefed them properly. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled. Then, I requested two available independent witnesses namely (i) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS-Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that 11/12 persons were assembled in an abandoned railway quater, situated at BRI Colony under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted five (05) accused persons while 06/07 hot chase we managed to apprehended above noted five (05) accused persons while others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multi color nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparations for committing Dacoity at BRI Colony and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 01.22 hrs to 01.40 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS and brought all the five (05) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with 06/07 of their associates who fled away, gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at BRI Colony.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted five (05) arrested accused persons namely (i) Bigen Mahato (24 yrs) S/O Rajendar Mahato of Lohar Patty, Gurung Busty, P.S. Pradhan Nagar, Dist. -Darjeeling (ii) Arun Biswakarma (22) S/O Lt. Raju Biswakarma of Haria Budhabari, PS. Jhapa, Nepal, A/P Darjeeling More, PS. Matigara, Dist. Darjeeling (iii) Biru Roy (28 yrs) S/O Niranjan Roy of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (iv) Santosh Mangar (32 yrs) S/O Lt Mani Kumar Mangar of Dentam, Namchi, PS- Namchi, Dist. South Sikkim, Sikkim and (v) Pinku Das (24 yrs) S/O Late Ananda Das of Lokkhi Colony, Dasarath Pally, Ward, No-44, PS- Bhakti Nagar, Dist. Jalpaiguri and others 06/07 unknown miscreants who fled away from the spot and arranged for its investigation.
