Sir,

With due respect, I am producing herewith two (02) accused persons namely (i) Prem Kumar (25 yrs) S/O Vinod Sah of Vill- Rautiniya Chamarua, PS- Karja, Dist. Mujaffarpur, Bihar and (ii) Santosh Kumar (23 yrs) S/O Shri Badri Sha of Vill- Rautiniya Chamarua, PS- Karja, Bihar under arrest and the following seized articles viz :-

1) Twenty one (21) cartoons of Magic Moments, Green vodka, each carton containing 12 bottles i.e, total $(12 \times 21) = 252$ bottles, each bottle containing 750 ml, ie, total $(252 \times 750 \text{ ml}) = 189$ litres, worth Rs $(252 \times \text{Rs } 355/-) = 89,460/-$, made in Sikkim - Marked as Exhibit "A" out of which one bottle randomly taken as sample for chemical examination and marked as Exhibit "A1".

2) Forty (40) cartoons of Green Label Whisky, each carton containing 12 bottles i.e, total $(40 \times 12) = 480$ bottles, each bottle containing 750 ml, ie, total $(480 \times 750 \text{ ml}) = 360$ litres, worth Rs $(480 \times \text{Rs } 307/-) = 1,47,360/-$, made in Sikkim - Marked as Exhibit "B" out of which one bottle randomly taken as sample for chemical examination and marked as Exhibit "B1".

3) Five (05) cartoons of Royal Castle, Blue Premium Whisky each carton containing 24 bottles i.e, total $(05 \times 24) = 120$ bottles, each bottle containing 375 ml, ie, total $(120 \times 375 \text{ ml}) = 45$ litres, worth Rs $(120 \times \text{Rs } 128/-) = 15,360/-$, made in Sikkim - Marked as Exhibit "C" out of which one bottle randomly taken as sample for chemical examination and marked as Exhibit "C1".

4) Five (05) cartoons of Blue Premium Whisky each carton containing 48 bottles i.e, total $(05 \times 48) = 240$ bottles, each bottle containing 180 ml, ie, total $(240 \times 180 \text{ ml}) = 43.2$ litres, worth Rs $(240 \times \text{Rs } 66/-) = 15,840/-$, made in Sikkim - Marked as Exhibit "D" out of which one bottle randomly taken as sample for chemical examination and marked as Exhibit "D1".

5) Forty (40) cartoons of King Fisher Strong Premium Beer each carton containing 24 Cans i.e, total $(40 \times 24) = 960$ Cans, each can containing 500 ml, ie, total $(960 \times 500 \text{ ml}) = 480$ litres, worth Rs $(960 \times \text{Rs } 88/-) = 84,480/-$, made in Sikkim - Marked as Exhibit "E" out of which one bottle randomly taken as sample for chemical examination and marked as Exhibit "E1".

6) One goods carrier vehicle having Registration number BR/01/GN/5239- Marked as Exhibit "F".

I SI Bandhan Roy of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above noted two arrested accused persons namely (i) Prem Kumar (25 yrs) S/O Vinod Sah of Vill- Rautiniya Chamarua, PS- Karja, Dist. Mujaffarpur, Bihar and (ii) Santosh Kumar (23 yrs) S/O Shri Badri Sha of Vill- Rautiniya Chamarua, PS- Karja, Bihar to the effect that on 08.09.2025 at 23.45 hrs. I received a specific source information that one vehicle having Registration number BR/01/GN/5239 loaded with huge quantity of illegal liquor is coming from Sikkim side with a view to go to Bihar. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 490 dated 08.09.2025 and informed the matter to you. As per your kind order and direction, I along with SI Goutam Mallik, ASI Bikash Roy, ASI Biplab Kr Das, ASI Anwar Abedin and force all of Pradhan Nagar PS left for Naka Point on NH 10, near Ganesh Ghosh Ghosh Colony More under PS Pradhan Nagar, Dist. Darjeeling by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Naka Point, I requested night RT van officer SI Debabrata Khan to come to the Naka Point on NH 10 near Ganesh Ghosh Colony to accompany with us. At around 00.05 hrs we arrived at Naka Point on NH 10 near Ganesh Ghosh Colony more and found SI Biswajit Biswas along with his team were engaged to perform Naka Chacking at the said Naka point. I shared the information with SI Biswajit Biswas and his team and requested them to accompany with us. After arrival at Naka Point, I contacted with my source who sated that the vehicle loaded with illegal liquor is coming towards Siliguri via Bhakti Nagar side and the said vehicle will reach shortly. Thereafter, I requested two available independent witnesses namely (i) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Then, we started at Naka Checking on NH 10 near Ganesh Ghosh Colony under PS- Pradhan Nagar, Dist. Darjeeling. At around 01.25 hrs we stopped the said goods carrier vehicle having Registration number BR/01/GN/5239 at the said Naka point and found the driver and co driver were inside the driver cabin. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation the driver of the said detained vehicle disclosed his identity as Prem Kumar (25 yrs) S/O Vinod Sah of Vill- Rautiniya Chamarua, PS- Karja, Dist. Mujaffarpur, Bihar and co driver disclosed his identity as Santosh Kumar (23 yrs) S/O Shri Badri Sha of Vill- Rautiniya Chamarua, PS- Karja, Bihar. On interrogation they disclosed that there are total 111 (one hundred eleven) cartoons of Sikkim made liquor loaded in the vehicle. Then we opened the back side door of the said vehicle and found the above mentioned liquors are loaded in the said vehicle. On demand they failed to produce any documents in respect liquor recovered from their possession. On further interrogation they disclosed that they loaded the said quantity of illegal Sikkim made liquor from Sikkim with a view to sale the same in Bihar in high price for their wrongfull gain. During local enquiry it could be revealed that both the detained persons namely (i) Prem Kumar (25 yrs) S/O Vinod Sah of Vill- Rautiniya Chamarua, PS- Karja, Dist. Mujaffarpur, Bihar and (ii) Santosh Kumar (23 yrs) S/O Shri Badri Sha of Vill- Rautiniya Chamarua, PS- Karja, Bihar are running such type of illegal business of selling illicit liquor without any valid documents for their wrongfull gain. As the accused persons namely (i) Prem Kumar (25 yrs) S/O Vinod Sah of Vill- Rautiniya Chamarua, PS- Karja, Dist. Mujaffarpur, Bihar and (ii) Santosh Kumar (23 yrs) S/O Shri Badri Sha of Vill- Rautiniya Chamarua, PS- Karja, Bihar has violated the norms of Bengal Excise Act, Hence, I seized the above noted articles under proper seizure list in presence of witnesses and arrested both the detained persons under proper memo of arrest and after informing him regarding ground of their arrest and brought to Pradhannagar PS to proceed further investigation. The entire process of search and seizure was made under the coverage of video graphy in between 01.55 hrs to 03.15 hrs on 09.09.25 at the spot as per norms of BNSS.

Therefore, I pray before your good self that a specific case may kindly be initiated against the above mentioned accused persons namely (i) Prem Kumar (25 yrs) S/O Vinod Sah of Vill- Rautiniya Chamarua, PS- Karja, Dist. Mujaffarpur, Bihar and (ii) Santosh Kumar (23 yrs) S/O Shri Badri Sha of Vill- Rautiniya Chamarua, PS- Karja, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
