

Sir,

In producing herewith following seized articles as per seizure list viz :- (i) one red colour tractor styled as "Mahindra Arjun Ultra-1" having registration number WB/73/G/3063 loaded with illegally mined river bed materials and (vi) 03 (three) numbers of shovels. I, ASI Prabal Sarkar of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver and owner of the seized vehicle having registration number WB/73/G/3063 to the effect that today (10.09.2025) at 11.15 hrs, I received a specific source input regarding illegal mining activity being carried out at the Mahananda river bed near lalchad ghat, Milon More under Pradhan Nagar PS, Dist. Darjeeling. It was reported that river bed materials were being illegally excavated and loaded in the vehicle for their illigal gain. Upon receipt of the information, I made a General Diary entry vide Pradhan Nagar PS GDE No. 569 dated 10.09.2025 and informed to you. As per your kind order and direction, I proceeded with a team in a Govt. vehicle to verify the veracity of the information.

On the way the source informed that the vehicle is loading illegally mined river bed materials at Mahananda river bed near lalchad ghat, Milon More under Pradhan Nagar PS, Dist. Darjeeling. At around 11.45 hrs on arrival at near Lalchan Ghat, Milan More under Pradhan Nagar PS we found the one tractor was coming towards Milan More from Mahananda River ghat. Upon noticing the police presence, the driver stopped his vehicle at near Lalchan Ghat, Milan More under PS-Pradhan Nagar, Dist.-Darjeeling and fled away from the spot. We tried to apprehend him but fled away by crossing Mahandnda river. Upon physical verification, the vehicle having registration number WB/73/G/3063 we found the said vehicle is loaded with illegally mined river bed materials. I tried my label best to find out the owner and driver of the said detained vehicle but nobody came forward before me to claim the said vehicle. During local enquiry it could be revealed that the the owner and driver of the said detained truck mined river materials illegally from Mahananda river bed with a view to sale the same to their sesign customer for their illegal gian. Accordingly, I seized the following articles viz :- (i) one red colour tractor styled as "Mahindra Arjun Ultra-1" having registration number WB/73/G/3063 loaded with illegally mined river bed materials and (vi) 03 (three) numbers of shovels under proper seizure list in presence of witnesses at the site in between 12.35 hrs to 13.15 hrs under video surveillance under section 106 BNSS.

Under the above circumstances, I pray before you that a case be registered under appropriate sections of law against the driver and owner of the seized vehicle having registration number WB/73/G/3063 and arrange for its investigation.
