I Priya Das, wife of Manik Das, aged about 37 years residing at **Dashrath Pally Ward No. 44, Siliguri**, beg to lodge the following complaint against **Ujal Das, Ranjit Das, Sujol Das, Surojit Das and prasanjit Das all resident of Dashrath Pally Bazar, ward No-44**, for your necessary action.

That on 06.09.2025, at around 10 P.M, when I was returning back to my home from my work alone at Dasrath Bazar, the above named miscreants who happens to be the influential person of this locality hit me and they also tied my hand in front of their house and said that they will kill me and my children. They were too aggressive and taking the advantage of me being alone they also molested me and physically assaulted .They also tried to touch my body parts forcefully and after half and hour they left me and said "Agar koi police complaint kiya to tereko mardega aur tera bacha ko bhi".I also came to know that various criminal cases are pending against some of them. The very next day I went to hospital and the delay for filing of this complaint is my bad health as I was in bed rest also had a fear that they will kill me if I file this Complaint.

Therefore, I pray that an FIR be registered against **Ujal Das, Ranjit Das, Sujol Das, Surojit Das and prasanjit Das** all son of Pradip das and Immediate legal action including their arrest be taken ,my safety and that of my children be ensured, and necessary police protection be arranged forthwith. I am also enclosing the medical documents.
