Sir,

In producing herewith one arrested accused person namely Souvik Kundu @ Tipu-32yrs s/o Lt Subhash Kundu of Baikunthapally, near Shiv Mandir, ward no-41 PS Bhaktinagar Dist Jalpaiguri with seized articles viz. (1) one Improvised iron made 7.65 automatic pistol fitted with magazine, trigger, which barrel in length approx 6" and butt in length approx 4" (2) Two pieces of live ammunitions marked as 7.65 mm (3) One i-phone vide IMEI No-356064800560555 with Sim no-8450820007

I SI Srimanta Chatterjee of Bhaktinagar Police Station do hereby lodge this written complaint against the above noted accused person to the effect that on 11.09.25 around 23.40hrs received a Secret Information from my source that one person has possessing one fire arms in his house at Baikunthapally under Bhaktinagar PS with. This refers to Bhaktinagar PS GDE No-606 dated 11.09.25.

Accordingly, I informed the intelligence to I/C Bhaktinagar PS and under his direction I proceeded to work out the information. This refers to Bhaktinagar PS GDE no- 607 dated 11.09.25. On 12.09.12 at 00.05 hours we arrived at Baikunthapally area, again contacted with my source and being indicated and identified by him, I along with my team accompanied with SI Youel Lepcha, ASI Dhurbo Misra, ASI Khagen Barman and Const/374 Debraj Biswas all of Bhaktinagar PS entered into the house of that person without any delay. we apprehended him and disclosed our identity as the police personnel of Bhaktinagar PS. On examination he disclosed his name and identity as noted above and also disclosed the information at hand. Without delay we held search of his person in presence of available witnesses namely (1) Koushik Ghosh-s/o Krishna Ghosh of Baikunthapally, near Shiv Mandir, ward no-41 PS Bhaktinagar Dist Jalpaiguri and (2) C/374 Debraj Biswas of Bhaktinagar PS under Siliguri Police Commissionerate and recovered one Improvised iron made 7.65 automatic pistol fitted with magazine, trigger, which barrel in length approx 6" and butt in length approx 4" (2) Two pieces of live ammunitions marked as 7.65 mm (3) One i-phone vide IMEI No-356064800560555 with Sim no-8450820007 from his exclusive possession which was concealed in his left waist.

On interrogation, the accused person made incoherent statement regarding possession of the fire arms. On demand he failed to produce any license/documents in respect of those fire arms.

In presence of the witnesses I seized the recovered above noted the fire arms with ammunitions under proper seizure list duly signed by the witnesses and the accused person after preparing label. Accordingly, I arrested the accused Souvik

Kundu @ Tipu-32yrs s/o Lt Subhash Kundu of Baikunthapally, near Shiv Mandir, ward no-41 PS Bhaktinagar Dist Jalpaiguri for violation provisions under Arms Act. Ground of arrest informed to the accused person and issued proper arrest memo. During enquiry it came to learn that the arrested person was moving at that locality since last few days with the fire arms. Seizure was made on 12.09.25 in between hrs 00.15hrs to 00.45hrs. The whole procedure of search & Seizure was conducted under proper audio visual record.

On the above circumstances, I pray that a specific case under proper section of Arms Act. may kindly be started against the accused Souvik Kundu @ Tipu-32yrs s/o Lt Subhash Kundu of Baikunthapally, near Shiv Mandir, ward no-41 PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
