Sir,

I, ASI Debasish Das of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Md Safique (21 yrs) S/O Md Tetar of Coal Depot, Ward No. 07, PS- Siliguri, Dist- Darjeeling, (2) Subir Sarkar @ Bocha (55 yrs) S/O Late Anil Chandra Sarkar of Fueswari, Ward No. 23, PS- Siliguri, Dist- Darjeeling and (3) Palash Mnadal (28 yrs) S/O Late Pujan Mandal of Shantinagar near Shantinagar Sporting Club, PS-Bhaktinagar, Dist-Jalpaiguri, (4) Niki Das (22 yrs) S/O Late Jagannath Das of Kumartali, PS- Siliguri, Dist- Darjeeling and (5) Md Rahul (19 yrs) S/O Md Safique of Tinbatti more near beside of Bank of India , PS- NJP, Dist- Jalpaiguri under arrest along with following seizure articles; (i) One steel made knife with plastic handle measuring approx 11 inches, recovered from the possession of Md Safique (which was on his hand ) (ii) One Iron made Rod measuring 28' inches, recovered from the possession of Subir Sarkar @ Bocha ( it was on his hand), (iii) One Iron made Hacksaw blade with frame measuring 17' (Approx) inches, recovered from the possession of Palash Mnadal (it was on his hand) ,(iv) One Shaw blade with plastic handle measuiring 16 inches recovered from the possession of Niki Das (it was on his hand) and (v) One rope mearing 27 fit recovered from the possession of Md Rahul ( it was on his hand), In this regard, I beg to report that on 12.09.2025 at 00.35 hrs received secret reliable source information that about 10/12 anti socials being armed with deadly weapons assembled at Fuleswari near Railway Gate, South Bharat Nagar, ward no. 24 under Siliguri PS for making preparation to commit dacoity in a house at South Bharat Nagar area under Siliguri PS. I informed this source information to I/C Siliguri PS and noted the information vide Siliguri PS GDE No. 539 Dated 12.09.2025. As per the direction of I/C Siliguri PS, at 00.45 hrs, I along with ASI Rabin Lama, ASI Minhaj Al Kader, ASi Sanjay Basunia, C/1563 Joy Chhetri, C/160 Soumen Sarkar along with investigation Kids left for Fuleswari near Railway Gate, South Bharat Nagar, ward no. 24 under Siliguri PS for working out the information vide Siliguri GDE No.540 Dated 12.09.2025 after briefing officers and force properly. At 00.55 around hrs we reached at Fuleswari near Railway Gate, South Bharat Nagar, ward no. 24 under Siliguri PS and kept our vehicle at considerable distance Fuleswari near Railway Gate, South Bharat Nagar, ward no. 24 under Siliguri PS. Then, I along with other Officers and force headed towards Fuleswari near Railway Gate, South Bharat Nagar, ward no. 24 under Siliguri PS looking for witnesses, if any on the way and found nothing. By this time we reached at Fuleswari near Railway Gate, South Bharat Nagar, ward no. 24 under Siligufi PS, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted three persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and

address as noted above and admitted that they along with 07/08 others assembled at the spot making preparation to commit dacoity tonight in a house at South Bharat Nagar area under Siliguri PS. I accordingly searched them in presence of witnesses and found (i) One steel made knife with plastic handle measuring approx 11 inches, recovered from the possession of Md Safique (which was on his hand ) (ii) One Iron made Rod measuring 28' inches, recovered from the possession of Subir Sarkar @ Bocha ( it was on his hand), (iii) One Iron made Hacksaw blade with frame measuring 17' (Approx) inches, recovered from the possession of Palash Mnadal (it was on his hand) ,(iv) One Shaw blade with plastic handle measuiring 16 inches recovered from the possession of Niki Das (it was on his hand) and (v) One rope mearing 27 fit recovered from the possession of Md Rahul ( it was on his hand) were making preparation for committing Dacoity tonight in a house at South Bharat Nagar area under Siliguri PS but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of above mentioned witnesses under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 01.25 hrs and 02.45 hrs dated 12.09.2025. The whole search, seizure and label were made under Videography. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at South Bharat Nagar area, but others managed to escape from the spot.On further interrogastion, it is also revealed from the statement of accused Md Rahul that Md Zakir was also there but meanwhile Md Zakir managed to flee away from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity in a house at South Bharat Nagar area under Siliguri PS.

Further, it is to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons, Md Zakir and others 06/07 others who fled away, under proper section of law and to cause its investigation.
