In producing herewith following three accused persons named (i) Sany Das, aged 25 years, s/o- Late Montu Das, resident of Gossainpur, Rupsingjote, PS- Bagdogra, Dist- Darjeeling, (ii) Tapas Biswas, aged 29 years, s/o- Shakti Biswas, resident of Shivmandir, Sharat Nagar, PS- Matigara, Dist- Darjeeling and (iii) Sanjit Mahato @ Desh, aged 22 years, s/o- Ramchandra Mahato, resident of Bagdogra Station More, Tiger Busty, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

- (i) One iron-made pliers with red colour plastic handle seized from the possession of Sany Das and marked as Exhibit-A.
- (ii) One screw driver with green colour plastic handle seized from the possession of Tapas Biswas and marked as Exhibit-B.
- (iii) One black and sky blue colour torch light styled as "KENNEDE Gold, Model: KG-6628" seized from the possession of Sanjit Mahato @ Desh and marked as Exhibit-C.
- (iv) One iron made rod having approx length 2'6" and marked as Exhibit-D.
- (v) One sky blue colour side bag styled as "Lovely Rabbit" and marked as Exhibit-E.
- (vi) One nylon rope measuring approx length 16 feet and marked as Exhibit-F.
- (vii) One iron-made knife measuring approx length 8 inches with wooden handle and marked as Exhibit-G.
- (viii) One steel made hacksaw blade measuring approx length 12 inches and marked as Exhibit-H.

I, ASI Munna Ahmed of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested three involved accused persons and other 3/4 absconding unknown miscreants to the effect that today on 11.09.2025 at 00:15 hrs I received reliable source information that some suspects have assembled near Singhijhora more beside AH-02 under Bagdogra PS with a preparation to commit dacoity at Bagdogra area. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I formed a raiding team consisting SI Binup Mahato, ASI Amit Lama, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar leaded by me. Then we left for Singhijhora more under Bagdogra PS by Govt. vehicle No. WB61A/0137 to work out the secret source information. This refers to Bagdogra PS GDE No. 463 dated 11.09.2025. At around 00:25 hrs we reached near Singhijhora more beside AH-02 and made an ambush there and waited for source indication. We parked our Govt. vehicle away from the place. In the mean time, source indicated us the group of suspects. There were a group of about 6/7 suspects. Then, being shown & indication by source we started to cordon them from all side. All of a sudden, some of them noticed us and tried to flee away from the spot. But after hot chase with the help of accompanying Police team we managed to apprehend three suspects there in red-handed at around 00:46 hrs. We searched for independent witnesses. Two independent witnesses named Barun Roy, aged 20 years, s/o- Late Ram Sogarath Roy, resident of Singhijhora TE, PS- Bagdogra, Dist- Darjeeling (PH. No. 82073-74702) and Md. Ramjan, aged 20 years, s/o- Md. Fakira Roy, resident of Pati Colony, Pramod Nagar, PS- Bagdogra, Dist- Darjeeling (PH. No. 74701-11840) agreed to be present there. Accordingly, I arranged to search their persons. On search, iron-made pliers, one screw driver, one torch light, one iron made rod, one side bag, one nylon rope, one iron-made knife and one hacksaw blade were recovered from their joint possession. Accordingly, I interrogated them. On interrogation, they could not give any satisfactory answer regarding their presence at that place at the odd hours of night. They gave different
