RESPECTED SIR,

I MRS. SOMA SAHA WIFE OF MR. BAPPA SAHA RESIDENT OF HAKIMPARA, SILIGURI WANT TO INFORM YOU THAT MY HUSBAND OWNS A SHOP IN BIDHAN MARKET STALL NO: T-266, ON 12TH OF SEPTEMBER 2025 BETWEEN 4:30PM TO 5PM WHILE MY HUSBAND WAS WORKING IN HIS SHOP, MRS. PARSHOJYOTI SAHA @ GUDDU BORA WIFE OF MR. BAPI SAHA RESIDING IN SHANGHATI MORE, EAST VIVEKANANDA PALLY, WARD NO.38, SILIGURI CAME TO OUR SHOP AND STARTED HITTING MY HUSBAND WITH HER SHOE'S AND ABUSING HIM WITH SUCH LANGUAGE IN FRONT OF MY STAFF AND EVERYONE PRESENT OUT THERE, THE LANGUAGE THEY USED THIS CAN'T BE DESCRIBE HERE. WHEN I WAS INFORMED ABOUT THIS I RUSHED TO OUR SHOP TO HELP HIM BUT AFTER I REACHED THERE MRS PARSHOJYOTI SAHA AND BAPI SAHA STARTED HITTING ME PHYSICALLY AND EVEN THEY TORE OFF MY CLOTHS. AFTER ONE HOUR WHEN MY MOTHER-IN-LAW CAME TO OUR SHOP TO HANDLE THE SITUATION AND WAS TALKING WITH MY HUSBAND AT THAT MOMENT MRS. PARSHOJYOTI SAHA & MR BAPI SAHA AGAIN CAME TO OUR SHOP AND STARTED PHYSICALLY HITTING MY MOTHER IN LAW AND GRABBING HER HAIRS AND THREW HER OUTSIDE THE SHOP, AFTER ALL THIS INCIDENT THEY EVEN THRETEEND US THAT TODAY AT NIGHT THEY WILL COME TO OUR HOUSE WITH WEAPONS TO KILL US.

SO ITS MY EARNEST REQUEST TO YOU SIR TO PROTECT US AND PLEASE TAKE A STRICT ACTION AGAINST MRS. PARSHOJYOTI SAHA AND MR BAPI SAHA SO THAT IN FUTURE HE DON'T REPEAT THE SAME WITH ANY OTHER PERSON.
