I, Smt Priyadarshini Pandit, wife of Sri Riva Lama, R/O Hotel Grove Hills, Laden-la Road, Darjeeling -734101, beg to lodge the following complaint against Sri. Dinesh Agarwal and Smt Sapna Agarwal R/O Block F-22, House no-01, Uttorayon Township, Matigara who by deception and forgery, cheated me and my company of a huge sum of money.

That I am one of the Director of M/s Priva Infra Pvt. Ltd. The said company was allotted a commercial unit, allotted a commercial unit, being Unit No. CCSGJ002, at City Centre, Siliguri, by Ambuja Realty Development Limited vide allotment letter dated 01.08.2016, Customer ID 100002368.

That thereafter, Sri Dinesh Agarwal and Smt Sapna Agarwal(wife of Sri Dinesh Agarwal) took an interest in buying my property and approached my company through Sri Mehul Garg who is the nephew of Dinesh Agarwal and R/O Bhagwat Apartment, Shiv Mandir Road, Punjabi Para, Haiderpara, Ward No 40, Siliguri (m corp), Jalpaiguri 734001 for purchasing the said allotted unit. After negotiations, it was mutually agreed at 3 total consideration amount of ₹2.90 crores, out of which ₹1.24 crore was paid into the account of M/s Priva Infra Pvt. Ltd and ₹20 lakhs in the account of Smt Priyadarshini Pandit (totalling around ₹1.44 crore) whereas the remaining outstanding balance ₹1.46 crore was agreed to be arranged through a loan to be sanctioned jointly in the names of Sri Dinesh Agarwal

and Smt Sapna Agarwal.

That accordingly, ICICI Bank sanctioned Loan A/c No. TBSGI00007397702 amounting to ₹2.30 crores in favour of Sri Dinesh Agarwal and Smt Sapna Agarwal. Out of the said loan, two disbursements were made on 29.03.2025 as follows:

- ₹1.03,80,000/- vide cheque no. 521430, ICICI Bank, in favour of Priva Infra Pvt. Ltd.,
- ₹1,24,78,518/- vide cheque no. 521431, ICICI Bank, in favour of Sri Dinesh Agarwal.

That the cheque of ₹1,03,80,000/- (Rupees One Crore Three Lakh Eighty Thousand only) bearing No. 521430, though shown as disbursed in favour of Priva Infra Pvt. Ltd., was in fact never delivered to the company. Instead, another cheque of ₹1,24,78,518/- (Rupees One Crore Twenty-Four Lakh Seventy-Eight Thousand Five Hundred Eighteen only) bearing No. 521431 was issued directly in favour of Sri Dinesh Agarwal. This disbursement itself was defective and irregular, since the loan was sanctioned specifically for the purchase of Unit No. CCSGJ002 allotted to Priva Infra Pvt. Ltd.

hat it is evident that the said cheque in favour of Sri Dinesh Agarwal was sued by ICICI Bank on the strength of a forged and fabricated document, amely the so-called "Letter of Relinquishment of Right, Title and Interest" arportedly issued by Priva Infra Pvt. Ltd. in favour of Mr. Dinesh Agarwal.

nat upon learning of this fraudulent act and wrongful diversion of loan nds. Priva Infra Pvt. Ltd. immediately informed and requested ICICI Bank d., Siliguri Branch, to cancel the loan disbursement made under Loan count No. TBSGI00007397702, vide communication dated 27/05/2025.

at instead of honouring their obligations, the said Dinesh Agarwal, in lusion and conspiracy, fabricated a false and fraudulent "letter of inquishing Right, Title, Interest in favour of Mr. Dinesh Agarwal in respect the unit No. CCSGJ002" dated 25.03.2025, purportedly issued on behalf Priva Infra Pvt. Ltd. and addressed to Ambuja Realty Development lited.

It in the said forged letter of relinquishing Right, Title, Interest in favour 3ri Dinesh Agarwal in respect of the said unit, it was falsely stated that va Infra Pvt. Ltd.has relinquished all Right, Title, Interest In favour of Sri esh Agarwal. I state that neither I nor my company ever issued or horised to issue such letter of relinquishing Right, Title, Interest. The ne is a forged and fabricated document, prepared without authority, plution or consent of the company.

it by using such forged documents, Sri Dinesh Agarwal and Smt Sepna irwal dishonestly induced ICICI Bank to sanction the loan transaction I manipulated the diversion of funds, thereby misappropriating an ount of approximately ₹2,90,00,000/- (Rupees Two Crores Ninety Lakhs) I causing wrongful loss to me and my company.

at the above acts clearly reveal a pre-planned conspiracy by the Sri tesh Agarwal, Smt Sapna Agarwal & Sri Mchul Garg to cheat me and my apany under the guise of purchasing the property.

nerefore request your good office to Register an FIR against Sri Dinesh arwal, Smt Sapna Agarwal & Sri Mehul Garg under the appropriate tions of the BNS, 2023 investigate the matter thoroughly, seize the forged er of relinquishing right, and obtain certified copies of the soan and bursement records from ICICI Bank, Siliguri Branch, Prevent further suse of forged documents, take action against the accused persons and obsecute them in accordance with law.

equest that this complaint may kindly be treated as a formal FIR and bessary action be taken immediately.
