Sir,

With due respect and humble submission, I SI. Mritunjoy Roy of Matigara P.S do hereby lodge this written complaint to the effect that today on 15/09/2025. I was deputed to perform special Raid (MMDR) duty along with C/154 Mihir Sen and C/1422 Jagadish Ch. Roy. since 05:15 Am vide Matigara P.S. C.C. No. 73/2025, Dated 15/09/2025 and Matigara P.S. GDE No. 779, Dated - 15/09/2025. In course of said special raid duty I received a source information that one Tractor is coming from Balasan River loaded with River bed Materials towards Khaprail More under Matigara PS, which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to Balasan River side and on way near Balasan Bridge, Paulpara, on AH-2 under P.S.- Matigara we found one Vehicle (Tractor with trolley) bearing Regn. No. WB 73 G 3641 loaded with river bed materials in a high speed running toward Siliguri Side, somehow we managed to detain the said Tractor and on demand the driver of the vehicle could not produced any valid document in respect of the said loaded riverbed materials. It is crystal clear that the driver of the vehicle (Tractor) bearing Regn. No. WB 73G 3641 procures the river bed materials from somewhere clandestinely and illegally and was preceding to sale the same to their designated customer for their wrongful gain. Accordingly, I seized the Tractor having Regn. No. WB 73 G 3641 fitted with Trolley, loaded with River Bed Materials on the spot i.e. on A.H.-2, near Balasan Bridge, Paulpara with proper seizure list also arrested the driver of the seized vehicle namely Ajay Barman(32 Yrs/Male) S/O Lt. Ghutu Barman of Bamni Bhita, Chhoto Lachka, PO- New Rangia, P.S. Matigara, Dist. Darjeeling and also communicated him the ground of his arrest. Brought the seized vehicles to Matigara P.S and kept at P.S Compound and the arrested accused kept into the P.S Lock up after maintaining proper Hazat rules. The whole process of Seizure was made in between 09.47 hrs to 09.55 Hrs.

I therefore pray before your esteem that a specific case under proper section of Law may kindly be registered against the accused driver of the seized vehicle namely Ajay Barman(32 Yrs/Male) S/O Lt. Ghutu Barman of Bamni Bhita, Chhoto Lachka, PO- New Rangia, P.S. Matigara, Dist. Darjeeling and arrange for its investigation.
