In producing herewith two (02) accused persons namely (i) Esraul Haque (32 yrs) S/O Lt. Abdul Hakim of Baliadanga PS-Kaliachak, Dist.-Malda and (ii) Nazrul Islam (23 yrs) S/O Kalimuddin Sekh of Vill-Baliadanga, PS-Kaliachak, Dist.- Malda under arrest along with the following seizure articles viz:- (i) One ash colour back pack stylled as "LIIBYA" having four compartment which contains one transparent white colour packet, containing 587 grms of said to be Brown sugar marked as Exhibit "A", recovered and seized from the possession of Esraul Haque (32 yrs) S/O Lt. Abdul Hakim of Baliadanga PS, Kaliachak, Dist Malda and (ii) One coffee colour bag containing two packets of said to be brown sugar weighing (309 grms + 233 grms = 542 grms) rapped with transparent plastic Marked as exhibit "B", recovered and seized from the possession of Nazrul Islam (23 yrs), S/O Kalimuddin Sekh of Vill-Baliadanga, PS-Kaliachak, Dist.- Malda the ground of arrest duly been communicated with them.

I, SI Bandhan Roy, S/O Nanda Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted two (02) arrested accused persons namely (i) Esraul Haque (32 yrs), S/O Lt. Abdul Hakim of Baliadanga PS-Kaliachak, Dist.-Malda and (ii) Nazrul Islam (23 yrs), S/O Kalimuddin Sekh of Vill- Baliadanga, PS- Kaliachak, Dist.- Malda to the effect that on 12.09.2025 at 17:05 hrs I received a reliable specific secret source input that two pearsons would be come to Devidanga Bazar, Champasari area under PS - Pradhan Nagar, Dist. Darjeeling with huge quantity of illegal Narcotic Contraband (Brown Sugar) on their bags to deliver the same to their design customers.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 709 dated 12.09.2025 and I informed to you in writing. Subsequently, being directed by you at about 17:15 hrs myself along with SI Goutam Mallik, SI Rajiv Subba, ASI Prabal Sarkar, ASI Bikash Roy, ASI Biplab Kumar Das and others force of Pradhan Nagar PS, SPC left for Devidanga Bazar, Champasari under Pradhan Nagar PS, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving them opportunity for concealment of evidence or facility for their escape. This refers to Pradhan Nagar PS GDE No. 710 dated 12.09.2025 and M.C.C. No. 1855/25 dated 12.09.2025. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist- Darjeeling over telephone and requested him to come to Devidanga, Champasari under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graph if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer ASI Sanjib Mukherjee and share the information to him and directed him to come at Devidanga, Champasari, to accompany us.

At around 17:35 hrs we arrived at Ada Ghat, Champasari, under PS- Pradhan Nagar, Dist. Darjeeling and contacted with my source while he informed that the persons who possessing illegal Narcotic Contraband will come to Devidanga Bazar, Champasari to deliver the same to their customers shortly. Then, I requested two available independent persons namely (i) Nur Hossain (22 yrs) S/O Abdul Halim of Devidanga, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Lalbabu Malakar (19 yrs) S/O Basan Malakar of Devidanga, near Petrol Pump, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at the spot and act as independent witness if any search and if required seizure would be made upon which they agreed and gave their concent verbally. I also issued notice to the above mentioned two independent witnesses. In the mean time RT mobile officers Sanjib Mukherjee along with force came at the spot to assist us. There after, I again contacted my source who stated that the suspect carrying Brown Sugar will come shortly by TOTO from Champasari side to deliver the same to their designated customers at Devidanga Bazar, Champasari. At around 19:00 hrs as being identified by the source, we noticed that two persons with two bags in their possession came down from one TOTO, near Ada Ghat, Champasari. Accordingly, we cordoned the place from every possible corner and managed to detain both of them at Ada Ghat, Champasari, under PS- Pradhan Nagar, Dist. Darjeeling with one ash colour back pack and one coffee colour bag in their possession. Then, we disclosed our identities as Police personnel (as I along with 4/5 police personnel were in civil dress for our convenience) and informed them regarding the information in hand. On interrogation, the detained persons disclosed their name and identity as (i) Esraul Haque (32 yrs) S/O Lt. Abdul Hakim and (ii) Nazrul Islam (23 yrs) S/O Kalimuddin Sekh both are from Baliadanga PS-Kaliachak, Dist.-Malda and also disclosed that they were possessing the Brown Sugar in their bags and came there to deliver the same to their designated customer. Then, I issued notice in writing to them whether they wanted to search their bags in presence of an Executive Magistrate or any Gazetted Officer as per norms u/s 50 of NDPS Act, upon which they agreed to be searched in presence of any of the above noted officers. Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. At around 19:10 hrs the above named videographer arrived at the spot with his camera.

Accordingly, I seized the said articles viz:- i) one ash colour back pack stylled as "LIIBYA" having four compartment which contains one transparent white colour packet, containing 587 grms of said to be Brown sugar marked as Exhibit "A", recovered and seized from the possession of accused Esraul Haque (32 yrs) S/O Lt. Abdul Hakim of Baliadanga PS-Kaliachak, Dist.-Malda and one coffee colour bag containing two packets of said to be brown sugar weighing (309 grms + 233 grms = 542grms) rapped with transparent plastic Marked as exhibit "B", recovered and seized from the possession of accused Nazrul Islam (23 yrs) S/O Kalimuddin Sekh of Vill- Baliadanga, PS- Kaliachak, Dist.- Malda under proper seizure list in presence of you and independent witnesses and obtained their signatures which is acknowledged by the accused persons. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused persons at the spot. The entire process of search, seizure and labelling were made under the coverage of a video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 19:45 hrs to 20:35 hrs as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that both the detined persons namely (i) Esraul Haque (32 yrs) S/O Lt. Abdul Hakim of Baliadanga PS-Kaliachak, Dist.-Malda and (ii) Nazrul Islam (23 yrs) S/O Kalimuddin Sekh of Vill-Baliadanga, PS-Kaliachak, Dist.-Malda are involved in procuring and selling "Narcotic substance" illegally contravening the provisions of NDPS Act. Then, I arrested them after observing all formalities of arrest, informing them regarding the ground of arrest.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested persons namely (i) Esraul Haque (32 yrs) S/O Lt. Abdul Hakim of Baliadanga PS-Kaliachak, Dist.-Malda and (ii) Nazrul Islam (23 yrs) S/O Kalimuddin Sekh of Vill- Baliadanga, PS- Kaliachak, Dist.- Malda and kindly arranged its investigation.
