I Puja Kumari (Mobile No.7384954879) daughter of Sri Ashok Sah, resident of Durga Nagar Colony, Gurung Basti, Ward No.III of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, Pin-734003 beg to report you the following facts:-

1. That to-day at about 3.30 P.M. to 4.00 P.M. some persons namely (i) Smt. Sima Soni wife of Chhotu Soni, (ii) Sonu Soni, (iii) Sandeep Soni both are son of Chhotu Soni, (iv) Komal Soni wife of Abhisek Soni, daughter of Chhotu Soni, (v) Abhisek Mandal son of Unknown, (vi) Sri Jaynarayan Swarnakar son of Unknown, (vii) Rajesh Swarnakar, (viii) Subhash Swarnakar both are son of Jaynarayan Swarnakar, (ix) Smt. Pramila Devi wife of Jaynarayan Swarnakar all are resident of Durga Nagar Colony, Gurung Basti, Ward No.III of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, came to my house room and started to create nuisance and insulted me and my family members by using unparliamentarily words abusing me very filthy languages when I was sleeping alone at my room suddenly they all are Physically assaulted me and brutally attacked with fists and blows and leather belt got severe injury of my person.

After that on that time my elder brother namely Kundan Kumar son of Sri Ashok Sah resident of Durga Nagar Colony, Gurung Basti, Ward No.III of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, came to the incident and try to rescue me from them, all are Physically assaulted with fists and blows and leather belt got severe injury on his chest and then they also physically assaulted me with their wrong intensions and touched my private body parts use of criminal force with intent to disrobe and outrage her modesty

after that anyhow I tried to save myself from their hands and my above said elder brother and I went to the Siliguri District Hospital, Siliguri, Dist. Darjeeling for medical treatment.

During such operation, they theft Rs.3,500/- under the pillow of my bed.

Now, they are abusing me and my family members very filthy languages and threatening me and my aforesaid elder brother by saying that if I go to the Police station to register / lodge any complaint against them then they will murder me and my aforesaid elder brother and drag our body outside from the city.

- 3. That I, my elder brother were got serious injury on our persons and lower abdomen and whole body swelling.
- 4. That due to such assault upon me and my aforesaid elder brother and due to their such attempt to murder of me in such cruel manners, I sustained severe injuries on my person and I was medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling on 12.09.2025 at 4.35 P.M. and still I am under medical treatment.
- 5. That due to serious injury caused due to such assaulted by them upon me and my aforesaid elder brother delay is caused for lodging this F.I.R. which may kindly be condoned.
- 6. That the Xerox copies of medical treatment paper are enclosed here with.

I therefore request you to kindly take necessary steps against the aforesaid culprits for the commission of the aforesaid offences upon my aforesaid elder brother and me.
