This is to bring to your notice that I, Falguni Mukherjee, S/O Late Sudhir Kumar Mukheriee, a Senior citizen of 72 years old & the resident of my own house at 39, Sadhak Ramprasad Sarani ward no: 29 (SMC/Siliguri), that today Dated:- 17.08.2025 , about 11.30 am in the morning my Elder brother Mr Tapan Kumar Mukherjee, a resident of the same compound with a different building called an Ameen from BL & LRO Office Siliguri to measure his (Tapan Mukherjee's) portion of total area(including his land & building), I also went downstairs to just be there with my brother but that time Mr Nitai Kumar Singh (who purchased one portion of the ground floor) came & started interfering & became very aggressive & started behaving badly with me, also started to say that I am no more the owner of the land & no one to decide anything about the land, when I objected to his (Nitai Kumar Singha's) statement he in front of my Elder brother Mr Tapan Kumar Mukherjee, Mrs Anita Mukherjee (wife of Tapan Mukherjee) ,Mr Swadhin Sarkar & his wife Mrs Sarkar, Mr Swapan Patra & his wife Mrs Soma Patra, his own wife Mrs Sampa Singha, stepped ahead to assault me but as I said that very moment, that if I receive even a scratch from his end, I will be compelled take action against him, on hearing this statement of mine he controlled himself.

Also to inform you that these kinds of activities happened earlier also, some of the incidents are mentioned below:-

1:-On 27.03.2025 My elder brother Mr Swapan Kumar Mukherjee already lodged a written complaint against Mr Nitai Kumar Singha (FIR:- 198/25-dated:- 28.03.2025) where he physically assaulted me & my brother both. He tried to squeeze my neck & kill me.

2:- He often uses slang languages to address me & on 27th July 2025 Sunday, I got to hear from upstairs that he was addressing me as "Ei Kuttar Baccha ta ke niche namiyei charbo" "Kono motei upore thakte debona"

3:- Today when my daughter came downstairs after hearing the high voice pitch of Nitai Kumar Singha, she was badly treated by Mrs Sadhin Sarkar & Mrs Sampa

- 4:- During the entire time of the incident Mrs Swadhin Sarkar, Mrs sampa Singha was using bad languages to address me & my daughter.
- 5:- Mr Swadhin Sarkar also interfered in this matter along with Mr Nitai Kumar Singha
- 6:- Also to inform you that Mr Nitai Kumar Singha's other partners in crime are Mr Swadhin Sarkar & Mr Swapan Patra

Also to inform you that a MISC Petition case No:- 39/2025 has been already registered by me in The Court of Ld. S.D.M (Maintenance Tribunal at the Sub-Divisional Office) at Siliguri under the Maintenance & Welfare of Parents & Senior Citizens Act, 2007, against Mr Swadhin Sarkar, Nitai Kumar Singha & Mr Swapan Patra & I have a copy of the order also.

Thereafter, I humbly pray to your kind honour to take an action under your judicious legal hands to pay justice as early as possible. Your expedite action in this regard will be highly appreciated.
