Respected Sir,

With due respect, I, Sri. Kailash Chandra Golwa, S/o. Sukhlal Golwa, resident of Upper M.G. Marg MW, Lal Market Road, Golwa Brothers, Gangtok Municipal Corporation, Gangtok, East Sikkim, Sikkim-737101 beg to state that I had lodged FIR against 1) PANKAJ PRASAD, 2) SHREE NATH PRASAD, 3) VISHAL KOTHARI (JAIN), on several occasions and lastly on 24/06/2025 regarding violation of court order passed by the Ld. Civil Judge Junior Division 1st Court at Jalpaiguri in connection with Title Suit No.111/2024 and a specific case is registered against them vide Bhaktinagar P.S. Case No. 600/2025 DATED 24.06.2025. Ld. Court has passed an injunction order thereby directed both parties to maintain status quo over the suit property in respect of the nature, character and possession of the same. As the accused persons again & again tried to violate the court order by changing nature and character of the suit land, the Ld. Court on an application filed by us i.e. the plaintiff in that case has also passed an order on 27.08.2024 vide order dated 27.08.2024 order No. 10 and directed the Officer-In-Charge to comply the order of the Court and also further directed to look into the matter for which Court order will not be violated in any manner causing any serious breach of peace there.

Today, i.e., on 05.08.2025, I visited the suit land in the morning and, to my shock, discovered that construction work has again been carried out over the past few days in our absence. The accused persons, being highly influential, appear to have no regard for or fear of law and order. Despite a subsisting court order and several complaints filed by us, they have brazenly proceeded using labourers and miscreants to extend a tin shed pucca room, construct a bathroom within the tin shed on a portion of the suit land and to raise a boundary wall over the existing one surrounding the suit land, all without any lawful authority and in blatant violation of the court's directives.

This act is not only illegal and contemptuous but has also caused us immense harassment and a sense of threat, even though we are the lawful owners of the property. Their continuous and willful defiance of the court's orders amounts to criminal contempt, trespass, and mischief, all carried out with the deliberate intention of usurping our legally owned land and undermining the authority of the judiciary and rule of law.

Therefore, I respectfully request you to take appropriate action against the aforementioned individuals and to take all necessary steps to ensure that such incidents are not repeated, and that the court's order is duly upheld. I shall remain deeply obliged for your kind intervention in this matter.
