Subject: Complaint regarding cheating, criminal intimidation, and attempt to dispossess from landed property

Respected Sir,

- I, Somali Ghosh, daughter of Dulal Ghosh, Hindu by religion, Indian by nationality, teacher by occupation, and resident of Ashrampara, Jatin Das Sarani, P.O. & P.S. Siliguri, District Darjeeling, do hereby lodge this written complaint as follows:
- 1. That I had entered into an agreement for sale with one Chhotan Ballav, son of Kartik Chand Ballav, resident of Ram Krishna Sarani, Sevoke Road, Siliguri, Ward No. 41, Siliguri Municipal Corporation, P.S. Bhaktinagar, District Jalpaiguri, in respect of a piece and parcel of land measuring 2 kathas situated at Mouza Binnaguri, Sheet No. 10, L.R. Khatian No. 4043, R.S. Khatian No. 1061, L.R. Plot No. 137, R.S. Plot No. 192, District Jalpaiguri.
- 2. That at the time of execution of the said agreement, I had paid an advance consideration of Rs. 50,000/-. Thereafter, on different occasions, I paid a further sum of Rs. 9,00,000/-, out of which Rs. 6,00,000/- was paid through bank transfer and the remaining amount in cash.
- 3. That upon receipt of the entire consideration money, the said vendor handed over possession of the land to me, whereupon I constructed a boundary wall and a tin-shed structure, incurring an expenditure of approximately Rs. 2,00,000/-.
- 4. That despite having received the full consideration, the said accused has failed and neglected to execute and register the deed of sale in my favour.

- That I repeatedly requested the accused to complete the sale transaction, but he has refused to comply with my legitimate requests.
- 6. That for the last several days, the accused, in connivance with one Nikhil Mahonto, has been attempting to dispossess me from my lawful possession, claiming to have sold the land to the said Nikhil Mahonto. The accused persons are influential and dangerous, and I apprehend serious harm to my person and unlawful dispossession from the said land.
- 7. That total early morning above named accused persons have demolished my boundary wall along with tin shed structure and when I protested the above named accused outraged my modesty and threatened to kill me.

In the circumstances stated above, I request you to kindly take immediate and appropriate legal action against the accused persons to protect my life, liberty, and lawful possession of the said property.
