Sir,

I, Sri Manik Das, (45), Assistant Engineer (Electrical) & Station Manager, NJP Gate Bazar C.C.C, WBSEDCL, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Shri Gouranga Acharjee to the effect that, on 15.09.2025 in course of inspection, myself along with (1) Shri Bijoy Lakra, S/O: Bernard Lakra, Divisional Engineer (Elect.) of Darjeeling Regional office, WBSEDCL, (2) Sukanta Talukder, Sr. Office Executive, S/O: Late Santosh Talukder, (3) Shri Subhankar Neogi, Linesman, S/O: Late Swapan Kumar Neogi of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Shri Gouranga Acharjee, S/O: Late Gopal Acharjee of village: Santipara, PO: Bhaktinagar, P.S. NJP, Dist: Jalpaiguri at 14.00 Hrs. Prior entry to the premises, a notice was issued in the name of Shri Gouranga Acharjee for inspection of the said premises which was received by Shri Gouranga Acharjee, the consumer. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the consumer & the available witnesses we conducted inspection of that premises.

During inspection it was found that, there has one domestic connection vide consumer id: 412130672 in the name of Gouranga Acharjee in the premises from which he has made unauthorized extension of line to other commercial premises, where there has a disconnected service line vide consumer number 401693227 in the name of Parag Nandi having outstanding due amount Rs. 66,525.00. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line of consumer id: 412130672 was disconnected & unauthorized extension line to the disconnected premises was dismantled. During inspection load of electricity consumption as observed on the meter of consumer id: 412130672 in the same premises was 0.600 KW. On being asked, Shri Gouranga Acharjee admitted his guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Shri Gouranga Acharjee, S/O: Late Gopal Acharjee of village: Santipara, PO: Bhaktinagar, P.S. NJP, Dist: Jalpaiguri i i has committed offence for which he is liable for prosecution U/S 135(1) (e) of The Electricity Act' 2003 amended in 2007.

Inspection report was prepared. I seized the following article under proper seizure list on 15.09.2025 from 14.05 hrs. to 14.20 hrs at the same premises in presence of the consumer & the available witnesses.

Seizure: -

1. PVC cable, 2 core, length: 25 feet (Black colour).

Copies of seizure list and inspection report were delivered to Shri Gouranga Acharjee.

Therefore, I request you to kindly treat this complaint as F.I.R. against aforesaid Shri Gouranga Acharjee and arrange for it's investigation.

Original inspection report, seizure list, notice, one sealed packet containing seized article affixed with original label and another seal packed C.D containing video recording are being handed over to you for necessary action.
