Subject: Formal Complaint against Ashok Dhar (Mb.8944810267),resident of Matigara (my husband) for causing Assault, Grievous Hurt, Cruelty and Rape to me on the night of 15.09.2025 in an intoxicated state.

Respected Sir/Madam,

I, Putul Dhar, daughter of Late Akhil Dhar , residing at Ward No – 25, Pushpa Vila, Children Park, New Milanpally, Saktinagar Siliguri, West Bengal -734005, seek your indulgence to lodge a formal criminal complaint against my husband, Ashok Dhar, son of Late Baidyanath Dhar , residing at Matigara (Mb . 8944810267)

On the night of 15.09.2025, my husband came to my residence at Ward No – 25, Pushpa Vila, Children Park, New Milanpally, Saktinagar Siliguri, and West Bengal -734005 Siliguri in a heavily intoxicated state. Without any provocation, he violently assaulted me. During the assault, he caused serious physical injuries to me, including grievous hurt to my private parts where I have undergone few stitches. Due to the severity of the injury, I had to be immediately admitted to [Siliguri District Hospital], where I received

medical treatment and stitches in my private part as would be evident from the reports of the Siliguri District Hospital.

He punched me in my chest and punched me on face multiple times, used blade to harm, heavy bleeding from vagina which required stitching and also raped me inasmuch as when I refused, he beat me more, the daughters were not at home when they arrived he even beat Shreya Dhar (elder daughter) scratched her.

My husband brutally raped me and during the process caused grievous hurt to me which amounts to a serious criminal offence, constituting cruelty, physical abuse, grievous bodily harm and rape under relevant sections of the **Bharatiya Nyaya Sanhita, 2023** including but not limited to Sections **63, 64, 85, 115, 116, 117, 118, 130, 131, and 498A IPC**. I am attaching the medical report/discharge summary from the hospital, along with photographs (if applicable), and identity proof for your reference.

I am in fear for my life and safety, and I request immediate protection and strict legal action against my husband. I respectfully urge you to register my complaint as an FIR and initiate appropriate criminal proceedings against him as per the law.

Please acknowledge this complaint and take urgent steps in accordance with the law.


