up brick and hit on his head, and my brother

Sir, heavy bleeding started from the head
of my said son and he was immediately shifted
to Solegaon Distt. Hospital and got 03 stitches
on his head.

very desperate & dangerous in nature and
they have threatened me, my wife & son and
my daughter namely, Shebana Khatun @ Chandni
(16), for dire consequences, if we will not
leave our house.
