## Respected Sir/Madam,

I Rahul mandal son of Ramesh Mandal resident of M.R Road, Khalpara, Siliguri would like to inform you that I along with my uncle Rakesh Mandal and cousins brothers are tenants cum occupants in and over the suit property namely "Shankar Kali Bhander c/o Anup Mandal, Premises No- F/N/120/495/425" situated at M.R road, Khalpara near Siliguri Hindi High for Girls school, wherein a business of selling Pan and other small edible commodities was started far back almost 50 years ago by my grandfather namely Anup Mandal since decased.

That the original tenant of the said property was our grandfather since last more or less 50 years ago and in the year 2016/17 my uncle Rakesh Mandal for the first time upon receipt of a notice of an advocate namely Jay Agarwal came to learnt that the suit property under the name and style Bhopal Dharamsala has been transferred to and in favor of M/S S.T Builders, and thereafter my uncle Rakesh Mandal has duly replied to the said notice through his learned advocate. It is pertinent to mention here that the property under my occupancy was having a electric connection since from the very inception through sub meter installed in an within my premises. The electric connection was being supplied through the main meter installed at Bhopal Dharamsala premises.

That there is an ongoing civil dispute in between M/S S.T Builders V/s Rakesh Mandal being Title eviction suit No- 299/2017 wherein the learned civil court has not adjudicated the matter in its final form and I am depositing the monthly rent every month in time in accordance with the order passed by the learned Civil judge junior division court at Siliguri. That the plaintiff of the case i.e accused herein being unsuccessful till date to evict me from the suit property through the due process established by law and now has taken the law into his own hand and thereby has most illegally discontinued the electric supply over the suit property on 13.09.2025, and since last 10 days he is continuously creating obstacles and disturbing the smooth functioning of my business. They also threatened to kill me wherever they find me if I inform the incident to the police station.

That today in absence of my guardian (Rakesh Mandal) who happens to be my uncle, the said accused person namely Anil Goyal, Sunil Goyal, Anand Bansia and Ashish Goyal of M.R road Khalpara along with some others anti social elements came into my shop and assaulted me with hockey stick in my chest and also brutally assaulted me with fist and blows on my jaw which has deeply impacted my jaw and due to which I am unable to eat properly and perform my daily routine life.

Therefore, I pray that a complaint be registered against Anil Goyal, Sunil Goyal, Anand Bansia and Ashish Goyal and Immediate legal action including their arrest be taken, and further my safety and that of my shop be ensured as they have openly threatened to harm me and kill me if I lodge a complaint
