**SUB: Written Complaint Against ANAKUL BARMAN and his father namely
DINESH BARMAN and elder brother namely PALASH BARMAN.**

Respected Sir/Madam,

I, **SHRI JADAV BARMAN**, son of Late Anil Barman, resident of Jaldumur Para, Farabari, Post Office – Sahudangihat, Police Station – Bhorer Alo, District – Jalpaiguri, Pin – 735135, am writing to lodge a formal complaint against **SHRI ANAKUL BARMAN**, his father and his brother, all residents of the same locality. Approximately one and a half months ago, my elder son, **Joy Barman**, borrowed Rs. 300/- from Shri Anakul Barman, his neighbor. Shortly thereafter, while my son was riding our two-wheeler, **Shri Anakul Barman** stopped him, slapped him, and deliberately damaged the vehicle. After knowing the incident and when I came to know about the borrowed money, I returned the said amount to Shri Anakul Barman in full. However, even after repayment, **Shri Anakul Barman** continued to harass my son regularly, using filthy language and caste-based slurs, such as calling him names based on his Scheduled Caste identity. This caused serious emotional distress to my son and led him to suffer from depression and anxiety. On a separate occasion, Anakul Barman's father threatened me, stating: "Me and my two sons will kill your elder son," a statement that was also heard by multiple neighbors, though we initially chose not to report it.

On **15th September 2025**, at around **7:30 PM**, while my son was talking on the phone in an open ground near our house, **Shri Anakul Barman** suddenly attacked him with a sharp knife, targeting his throat. Due to the cuts on his throat, my son lost
