After marriage they both (Ganesh Mallick and Swapna Mallick) set out Gujarat Mota baracha Swrat for Job purpose. When they got girl child (birth) who ever name Kavya Mallick (Presently two years) at Swrat orca. And on suddenly my daughter in law Swapna Mallick got affairs to with Rusbah named person. And they both (Swapna Mallick and Rusbah) escape from their home Gujarat Swrat. And my son Ganesh Mallick lodged missing diary on 5-8-2025 at Katharajam Mahila Police Station who ever missing on 1-8-2025. At least 10-9-2025 Swapna Mallick and my son Ganesh done chaos at their Salkarita house. Suddenly Ganesh bwent by spread patrol whenever arrested both of them and Swapna's family member.
