I Sharouke Prasad (M/22 yrs) S/O- Late Sanjit Prasad of Jakir Hussain Road, Buchar Busty, PO+ PS- Sadar, Dist- Darjeeling state to beg you that I was suffering from Ectopic Kioney Stone disease since last one year. Three (03) months ago, I consulted with doctor at Star Hospital and doctor advised to do the operation as fast as possible otherwise it will turn into cancer. So, in immediate effect I along with my family members came at NBMC & Hospital and met with Raj Mallick and Laxman at NBMC & Hospital in the month of July, 2025 who introduced themselves as hospital staff and they assured us that the operation could be done at NBMC & Hospital and told us that they will take RS.30000/- for the operation. Accordingly I and my family members collected money for the operation and given total sum of RS. 30000/through online UPI and cash to the said Raj Mallick and Laxman from the period of August, 2025 to 08.09.2025 On 08.09.2025 Raj Mallick called me for admission at NBMC & Hospital and ac ordingly I came there and Raj Mallick told me to give him RS. 7000/- for admission but I was unable to paid the same to Raj Mallick and for that my admission could not be done at NBMC & Hespital. In the evening on 08.09.2025 I transacted RS.7000/- to Raj Mallick through UPI and Raj Mellick called us on 10.09.2025 for admission in the Hospital. Later on 10.09.2025 I got admitted at Uro Surgical Ward, Super Speciality Block of NBMC & Hospital by Raj Mallick. Raj Mallick told us that my operation will be done on 12.09.2025. But on 12.09.2025 he told us that today my operation cannot be done and on 16.09.2025 my operation date was fixed by doctor. Today on 16.09.2025 at about 09.00 hrs my family members arrived at Super Specialty ward an I taken to me at Operation Theatre where the senior doctor checked my reports and told us that my operation could not be possible at this Hospital. After that I along with my family nicimbers meet with Raj Mallick at infront of MM1 ward, NBMC & Hospital and he told us that he could not do anything. After that we told him to return our money which was given to him for operation but he denied returning the money. After that we asked him to go to the Police Station but suddenly he along with Bijay Mallick started assaulting me and my family members with fists and blows and Bijay Mallick ripped my OT clothes, injection channel. After some times, Police arrived to the spot and save us. Thus the way, they extorted our money and charted us.

So, I request you to investigate the matter and help us from your kind end as per law.
