With due respect and high regard, I, SI Prasan Tamang, presently posted at Sir, Matigara PS, Siliguri Police Commissionerate do hereby lodged a written complaint to the effect that on 17/09/2025 at about 22.15 hrs, when I was on off duty, I along with my wife and my sister in law were coming from sukna via lexicon road, under Matigara PS area by my four wheeler. When we reached time at near lexicon more in the mean time 1) Amar Lohar, S/o Khoka Lohar, 2) Rohit Mahali, S/O Kanchan Mahali and others eight to ten persons wrongly retrained my four wheeler and used flighty languages to me and my wife and demanded money. On being protested by me, the above mention two persons open the side front door of my car and grab the hair of my wife and drag her to ground and try to outrage her modesty. Seeing this I strongly protested them but the said persons assaulted me with fist, blows, stick and a sharp weapon with an intention to kill, where I received serious grievous injury on my face and body. Later Somehow, I along with my wife and sister in law try to manage to escape from the spot by car. Later I treated myself at Neotia Hospital for my aid.

Hence, I pray to your esteem that a specific case may kindly be started against the persons namely 1) Amar Lohar, S/o Khoka Lohar, 2) Rohit Mahali, S/O Kanchan Mahali both of Motajote near kali Mandir PS Matigara Dist Darjeeling and others 08 to 10 people and arrange for its investigation.
