Respected Sir,

1. I Ashish Goyal son of Sunil Kumar Goyal resident of S.P.Mukherjee Road, Khalpara, Siliguri, beg to inform you that our company **ST Developers Company Pvt. Ltd.** is the lawful and registered owner of a commercial space measuring about **250 sq. ft.** situated on the ground floor of a two-storied building standing over a plot of land measuring **10 kattas, 4 chattaks and 37 sq. ft.**, comprised in **R.S. Plot No. 3031, R.S. Khatian No. 303, Mouza Siliguri, Pargana Baikuntapur, J.L. No. 110(88)**, within Siliguri Police Station jurisdiction, and located at Khalpara, opposite Sitaram Hotel, Siliguri.
2. That when our company purchased the said property in the year 2015, the father of accused persons No.2 & 3 namely **Rakesh Mandal** was tenant in the said premises. After purchase, when rent was demanded by our company, said tenant refused to pay. Accordingly, a civil eviction case was filed by us which is still pending.
3. That recently, our company applied before the concerned Electricity Department on 28.08.2025 for **shifting of the electricity meter**, and on 13.09.2025 during the shifting process, it was discovered that the above-named accused persons were committing **theft of electricity** by illegally drawing power from our electricity meter.
4. That on 16.09.2025 at about 04.10 pm when I personally protested against such illegal act, the accused persons became violent, assaulted me with fists and blows, and

abused me in filthy language. In particular, accused **Rahul Mandal, Sourav Mandal, Amit Mandal** hit me severely on my chest, due to which I fell on the floor and momentarily lost consciousness. Taking advantage of the situation, the accused persons snatched away my **gold chain weighing about 25 grams** from my neck.

5. That the accused further criminally threatened me with dire consequences, stating that they would lodge false and fabricated cases against me and my company members.
6. That by their above acts, the accused persons have committed cognizable offences punishable under **the BNS 2023** and also under **Electricity Act, 2003 (theft of electricity)**.


In the aforesaid circumstances, I humbly request you to kindly register this complaint as an F.I.R. and take strict legal action against the above-named accused persons in accordance with law.
