Sir,

I, C/422 Chandan Murmu, son of Late Bijay Murmu, residing under Bhaktinagar P.S, Siliguri Police Commissionerate, wish to lodge a formal complaint regarding an incident that occurred near the Jaleswari Bazar area, opposite the Basanti Petrol Pump, under Ashighar OP.

On September 17, 2025, at approximately 11:45 AM, while on prisoner van duty from Bhaktinagar PS to the Ld. Court in Jalpaiguri, an accident took place near Jaleswari Bazar. Our prisoner escort van, bearing registration number WB74/8740, was crossing the area when a white four-wheeler with registration number WB74BN/5252, traveling in the same direction, collided with the escort van due to a brake failure of Prisoner van, causing minor damage to the other vehicle.

After the incident, local residents gathered at the scene and attempted to create a disturbance. With the intervention of the police team, we managed to clear the crowd and safely remove the prisoner van from the area.

Under these circumstances, I respectfully request that a specific case be initiated concerning this incident under the appropriate sections of the law and arrange for its investigation.
