Respected Sir,

I, **Ranjit Kumar Saha**, S/O. Late Kalipada Saha, resident of Gouranga Pally, Ward No. 40 of S.M.C., P.O. Haiderpara, P.S. Bhakti Nagar, Dist. Jalpaiguri, beg to report you the following facts:-

1. That I am the owner of three storied building, situated at Gouranga Pally, Ward No. 40 of S.M.C., P.O. Haiderpara, P.S. Bhakti Nagar, Dist. Jalpaiguri.
2. That one Narayan Mahanto, Son of not known along with his wife namely Smt. Krishna Mahanto, his daughter namely Nandita Mahanto, his son namely Ratan Mahanto and his daughter in-law namely Juhi Mahanto, wife of Ratan Mahanto used to reside back side of my house as tenant.
3. That on 03.9.2025 I engaged some Raj Mistri and Labour for some repairing work of my boundary wall of my house.

It, is to be mentioned here that since after entered in my house as tenant the aforesaid persons use to through garbage and waste and spread dirt from their house and also they continuously spitting on my wall. I several times requested and warn them so as to not to spit or spread dirt in my house, but they did not stop doing so. Even they intentionally throw the garbage and several times spitted when my labourers working there, seeing such dirt and filthiness my mistri stopped their work. My tenants abuse and threatened my labourers when they requested for not to spit at the time of their work. Any how my mistri complete their work. But my aforesaid tenants did not stop spreading dirt, garbage and spitting on the wall.

4. That seeing their rude and arrogant attitude I scolded them and asked them to vacate my house as early as possible. Hearing this all my above mentioned tenants started abusing me and in filthy and offensive languages, seeing the situation, I came back in my house and made a complain in our club (MahaSakti Sporting Club). And some person of the said club came and asked them to vacate my house, accordingly on 07.9.2025 they vacate my house. But they threatened me of dire consequences.
5. That today i.e. on 16.9. 2025, at about 6:30 p.m. when I came back to my house at that time Narayan Mahanto, Son of not known along with his wife namely Smt. Krishna Mahanto, his daughter namely NanditaMahanto, his son namely RatanMahanto and his daughter in-law namely JuhiMahanto, wife of RatanMahanto, all of sudden caught hold me at a nearby dark street of Ghugni more, Haiderpara, Siliguri and started abusing me in filthy and offensive languages, when I protested them, they became furious and started assaulting me by fists, blows and by kicks and belt. They mercilessly assaulted me almost 10-15 minutes, seeing this some passers-by gathered on the spot and rescued me from their clutch. Those miscreants snatched my neck chain made of gold weighing 10 grams and cash rupees 4500/- from my shirt pocket. Then and then some persons took me in Siliguri S.D. Hospital and I am under medical supervision.

I, therefore, request you to kindly take necessary legal action against the aforesaid persons for the commission of the aforesaid offences by them upon me.
