ASI Dipak Kumar Chhetri of Matigara PS, Siliguri Police Commissionerate beg to state that on 16.09.2025 at 23:49 hrs, received a secret source information that a gang of miscreants were assembled at a vacant land of Paribahan Nagar near I.T Park under Matigara PS, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Himachal Vihar. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Bikash Roy, C/219 Sanatan Chitrakar, C/523 Sanjit Kundu, C/868 Sujal Roy all are of Matigara PS, Siliguri Police Commissionerate left for Paribahan Nagar near I.T Park, PS- Matigara, Dist.- Darjeeling to work out the information in hand vide Matigara PS GDE No. 689, Dated- 16.09.2025. At about 23:45 hrs we arrived at near Paribahan Nagar near I.T Park under Matigara PS. After arrival of the spot and as identified by the source we found that 11/12 persons were assembled at a vacant land of Paribahan Nagar near I.T Park and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 05 (five) persons of them. On interrogation, the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation to commit dacoity at Himachal Vihar under Matigara PS. They also stated that others 06/07 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest was made in between on 16.09.2025 at 23:55 hrs to on 17.09.2025 at 00.20 hrs. The whole process of search & seizure was made under video graph. The videography was done by C/868 Sujal Roy.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i, Digen Singlia (26 Years approx), S/o-Sushil Singha of Bara Pathu Ramjote, PO- Ranapani,, PS- Phansidewa, Dist- Darjeeling (ii) Suman Sha (22 years approx), S/o- Suresh Sha of Matigara Biswas Colony, Po+ PS- Matigara, Dist- Darjeeting (iii) Md. Samiruddin (24 Years approx), S/o- Md. Ismuddin of Lelin Colony, PO+PS- Matigara, Dist-Darjeeling, (iv) Pabitra Singha (27 years approx), S/O- Ramesh Singha of Haler Matha, PO- New Rangia, PS- Matigara, Dist- Darjeeling, (v) Md. Jiarut (22 Years Apporx), S/o- Md. Ali of Fulbari, Amaidighi, PO- Fulbari Bazar, PS- NJP, Dist- Jalpaiguri and others and arrange for its investigation.
