In reference to above, I would like to inform you that as per the District Registrar, Darjeeling direction vide memo 928/DR.DJ/24 dated 27/12/2024 and complaint of Shri Biju Biswas, w/o Chitraranjan Biswas resident of Chapakhowa, PO & PS Sadiya, Dist : Dibrugarh, Assam the enquiry was conducted against alleged deed being number I-6993/2024 and the fact and findings, found after enquiry was forwarded to the District Registrar, Darjeeling vide memo 503/Adsrbag/2025 dated 04/09/2025 (attached herewith).
